## ORDINANCE ADDING ARTICLE 5.6.1 TO CHAPTER IV OF THE LOS ANGELES MUNICIPAL CODE TO PROTECT AFFORDABLE HOUSING OPPORTUNITIES FOR PERSONS USING RENTAL ASSISTANCE OR OTHER SOURCES OF INCOME SUCH AS SECTION 8 VOUCHERS AS PAYMENT

Honorable Members:

Pursuant to your request, this Office has prepared and now transmits for your consideration, approved as to form and legality, the enclosed draft ordinance adding Article 5.6.1 to Chapter IV of the Los Angeles Municipal Code (LAMC).

The draft ordinance protects affordable housing opportunities by prohibiting discrimination against persons based upon their source of income. The draft ordinance: (1) defines "Source of Income" to include rental assistance from any federal, state, local, or non-profit administrated benefit or subsidy program, including but not limited to, the Section 8 voucher program, the Los Angeles Homeless Services Authority's Rapid Re-Housing program or any other subsidy program, homeless prevention program or security deposit assistance program, whether paid directly to the program participant or to the landlord or landlord's representative; and (2) provides remedies for violations of its provisions.
