From page 2, paragraph one, bullet one of Neighborhood Council System Reform Motion -

I FURTHER MOVE that the City Clerk be INSTRUCTED, with assistance as needed from the CLA, CAO, DONE and City Attorney, to report back within 60 days on the following:

• Recommendations and next steps on a process for Neighborhood Councils to be able to roll-over a non-cumulative maximum of \$10,000 in any given fiscal year.

Suggested change

• Recommendations and next steps on a process for the City Clerk to create a special fund to be able to roll-over all Neighborhood Councils (NC's) remaining net available balance maximum of \$980,000 in any given fiscal year. This special fund will then be distributed to any/all NC's, upon request.

Discussion

Although the ability for NC's to be able to roll-over funds into the next fiscal year is needed, it penalizes NC's that have traditionally used most (>90%) of their annual budgets. It could be envisioned that these NC's may limit activity so that they could have access to a larger budget in the next fiscal year.

However, some NC's don't utilize most (<90%) of their current year funds, thus rewarding them with a larger budget the next fiscal year.

If a special fund were created to roll-over the total remaining balance from all NC's, all NC's could have access to those funds, on a first come first served basis, thus potentially benefiting all NC's (a request cap amount could be set; ex: max request of \$10k per NC).

Lastly, the maximum amount of the special fund would be equal to the amount if all NC's rolled-over \$10k; thus not changing the spirit of original recommendation by Councilmember Ryu.

Examples below taken from the Neighborhood Council Funding System Dashboard (as of 06/20/2018)

All NC's remaining net available balance; if roll-over into a special fund: \$514,864 / 98 NC's equal ~\$5300 per NC



Example: a NC that spends most of its funding; if roll-over: only \$186; insignificant budget increase to \$42,186



Example: a NC that spends less than most of its funding; if roll-over: \$10k; significant budget increase to \$52,000
