## MOTION

I HEREBY MOVE that the Council ADOPT the following recommendations of the City Attorney in order to effect settlement in the case entitled Jemica Gardiner v. City of Los Angeles, Los Angeles Superior Court Case No. BC648088 (this matter involves an alleged dangerous condition of public property arising out of a vehicle-versus-pedestrian traffic accident which occurred on Vista Del Mar between Imperial Highway and Napoleon Street, in the City of Los Angeles), **SUBJECT TO THE APPROVAL OF THE MAYOR:**

1. AUTHORIZE the City Attorney to expend \$750,000 in settlement of the above-entitled matter.
2. AUTHORIZE the Controller to transfer \$750,000 from the Liability Claims Fund No. 100/59, Account No. 009798, Miscellaneous Liability Payouts, to Fund No. 100/59, Account No. 009797, Transportation Liability Payouts.
3. AUTHORIZE the City Attorney to draw a demand from Fund No. 100/59, Account No. 009797, Transportation Liability Payouts, in the amount of \$750,000 and made payable to Paoli and Purdy, LLP Client Trust Account and Jemica Gardiner.
4. AUTHORIZE the City Attorney, or designee, to make necessary technical adjustments, subject to the approval of the City Administrative Officer; and, AUTHORIZE the Controller to implement the instructions.
