## MOTION

I HEREBY MOVE that the Council ADOPT the following recommendations of the City Attorney in order to effect settlement in the case entitled Jordan Evan Peart v. City of Los Angeles, Los Angeles Superior Court Case No. BC675114 (this matter arises from property damage and personal injuries sustained from a fallen parkway tree on April 28, 2017 in front of 21505 Erwin Street, Woodland Hills), **SUBJECT TO THE APPROVAL OF THE MAYOR:**

1. AUTHORIZE the City Attorney to expend \$175,000 in settlement of the above-entitled matter.
2. AUTHORIZE the Controller to transfer \$175,000 from the Liability Claims Fund No. 100/59, Account No. 009798, Miscellaneous Liability Payouts, to Fund No. 100/59, Account No. 009795, Public Works, Street Services Liability Payouts.
3. AUTHORIZE the City Attorney to draw a demand from Fund No. 100/59, Account No. 009795, Public Works, Street Services Liability Payouts, in the amount of \$175,000 and made payable to Law Offices of Jacques Beugelmans and Jordan Evan Peart.
4. AUTHORIZE the City Attorney, or designee, to make necessary technical adjustments, subject to the approval of the City Administrative Officer; and, AUTHORIZE the Controller to implement the instructions.
