Enclosed for your review is the Los Angeles Police Department's response to Adopted Budget Recommendation R.60 (C.F. 18-0600-S60) regarding how the Workers' Compensation and insurance systems work together, that was raised during the Fiscal Year (FY) 2018-19 Budget deliberations:

*Instruct the Police Department to report to the Public Safety Committee and the Personnel and Animal Welfare Committee on how the Workers' Compensation and insurance systems work together, including the impacts of having a dual system and a cost-benefit analysis of consolidating the systems to avoid double paying. The report should include an analysis of the benefits to the officers and the impact to the City.*

The Los Angeles Police Department recommends this response be prepared by the Personnel Department's Workers' Compensation Division. The Personnel Department is the appropriate respondent because they administer the City's Workers' Compensation Program and can provide comprehensive data analysis of the entire program.
