## Proposed NoHo West Sign Ordinance ENV-2015-888-EIR, CPC-2018-3276-SN

From the outset of the planning for development of the old Laurel Plaza site, its residential neighbors have made clear that no signage for the project would be welcome should it be visible from their surrounding residences. The developer seemed to agree to this very reasonable request, at least verbally. Now we have a sign ordinance proposed for NoHo West that includes two digital signs that will grossly intrude on its residential neighbors, especially those living south of Oxnard Street, its southerly boundary. A promise made will be broken if the proposed ordinance is approved including the digital signs. Remove the digital signs from this latest proposed sign ordinance, an ordinance sweetened from the previous one approved because the developer didn't feel that one was sweet enough. Disallow the proposed digital signs and help keep a promise made.



These signs' impact on the 170 Freeway must additionally be considered. The famous silent movie, **Safety Last**, tells the story of a guy risking his individual safety to make a fast buck. By scaling a big city building (downtown Los Angeles is the setting) he gains the publicity sought by a retailer and earns his cash. Here the story is reversed. The digital signs in the proposed ordinance will put public safety at risk so that a sign owner can make a fast buck. Southbound traffic on the 170 Freeway curves to the southeast just as the proposed northerly digital will come smack frontal into view. At the same location to the right, on-traffic from Victory Boulevard must negotiate with off-traffic to Oxnard Street using a very short weaving lane of less than 700 ft. This entry/exit stretch is a chronic accident location. Additionally, the soundwall now under construction on the 170 from the 134 to Sherman Way will span this entire stretch except the east side of the freeway from Victory to Oxnard. Thus southbound traffic, in addition to the chaos described above, will enjoy the additional distraction of having the soundwall to the left disappearing at the same time. Distractions cause accidents, and the proposed digital signs will make an already otherwise bad situation much worse! The Planning Commission has twice thoughtfully recognized the safety detriment associated with these signs and disallowed them. The PLUM Committee should likewise thoughtfully do the same.
