You are hereby notified that the Planning and Land Use Management (PLUM) Committee of the Los Angeles City Council will hold a public hearing on **Tuesday, September 18, 2018** at approximately **2:30 PM** or soon thereafter in the John Ferraro Council Chamber, Room 340, City Hall, 200 North Spring Street, Los Angeles, CA 90012 (entrance on Main Street), to consider the following: Categorical Exemption (No. ENV-2014-4125-CE) from California Environmental Quality Act (CEQA) pursuant to State CEQA Statutes and Guidelines, Section 15332, Class 32, and related CEQA findings, report from the Central Los Angeles Area Planning Commission (CLAAPC), and an appeal filed by Doug Haines on behalf of the La Mirada Avenue Neighborhood Association and Virgil Village Neighborhood Association (Representative: Robert Silverstein, The Silverstein Law Firm) from the determination of the CLAAPC in approving Vesting Tentative Tract No. VTT-73056-SL-1A, for the demolition of an existing duplex and subdivision of one 9,602 square-foot lot into six small lots pursuant to the Small Lot Subdivision Ordinance, and the construction, use and maintenance of a three-story, single-family dwelling with an attached two-car garage on each of the six subdivided lots and one uncovered guest parking space within Subarea A (Neighborhood Conservation) of the Vermont/Western Station Neighborhood Area Plan (SNAP) Specific Plan, for the properties located at 4321 and 4323 West Burns Avenue, subject to modified Conditions of Approval.
