B. Evaluation of Bid/Proposal

On July 21, 2017, LADWP issued a Request for Proposal (RFP) to evaluate and select a contractor for a three-year agreement. Three proposals were received by the August 31, 2017, due date. The proposals were evaluated for compliance with the RFP requirements by staff from FSO.

SBE/DVBE Participation Program Requirement was evaluated by LADWP's Office of Small Business and Supplier Relations. Financial Resources and Responsibility was evaluated by LADWP's FSO.

Navigant has been selected to provide the rate consulting services portion of the RFP bringing their expertise for the upcoming interim rate review. These services are covered under Tasks 3, 4, 5, 6, 7, 8, 11, and 12.

Under the prior agreement for rate consulting services, PA provided LADWP assistance with the rate design implemented under the current water and power ordinances. It is not advisable that the same consultant validate those same rates under the interim rate review for the purpose of maintaining transparency. Accordingly PA has been selected to provide only the formal cost studies and benchmarking assessment portion of the RFP. These services are covered under Tasks 1, 2, 9, and 10.

The recommended fee schedule has been determined to be fair and reasonable based on a comparison of all the proposals received under RFP No. 90401.
