The Los Angeles City Council will conduct a Public Hearing relative to the City Council's intention to confirm, levy and collect annual assessments totaling \$25 million for fiscal year 2019-20 to acquire land and develop, improve, restore and maintain parks and recreational facilities for the Proposition K: L.A. for Kids Program (City of Los Angeles Landscaping and Lighting District 95-1, formed pursuant to the provisions of the Landscaping and Lighting Act of 1972 (Division 15, Part 2, Streets and Highways Code, State of California).

The hearing will be held on June 5, 2019, at 10:00 a.m., or as soon thereafter as the matter can be heard, in the John Ferraro Council Chamber, Room 340, City Hall, 200 North Spring Street, Los Angeles, CA 90012 (public entrance is on Main Street). A copy of the proposed Ordinance ordering confirmation, levy and collection of the annual assessments and the related Assessment Report and Engineer's Report may be examined in the Office of the City Clerk, Room 395, City Hall, 200 North Spring Street, Los Angeles, 90012, as well as online at:
