

TRANSPORTATION COMMITTEE REPORT relative to prohibiting the parking of vehicles, displaying a For Sale sign or placard advertising their private sale, on certain segments of 10th Avenue.

Recommendation for Council action, pursuant to Motion (Wesson – Martinez):

REQUEST the City Attorney to prepare and present an ordinance amending Los Angeles Municipal Code (LAMC) Section 87.55 to prohibit the parking of vehicles, displaying a For Sale sign or placard advertising their private sale, on the 1900 - 2200 blocks of 10th Avenue.

Fiscal Impact Statement: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

### SUMMARY

On August 15, 2018, Council considered Motion (Wesson – Martinez) relative to prohibiting the parking of vehicles, displaying a For Sale sign or placard advertising their private sale, on certain segments of 10th Avenue. Motion states that LAMC Section 87.55 prohibits the parking of vehicles displaying a For Sale sign or placard advertising the private sale of that vehicle on certain identified street segments. After a public hearing has been held, Council can amend LAMC Section 87.55 to include additional streets or public lands.

Motion goes on to state that the critical shortage of on-street parking along 10th Avenue is exacerbated by individuals parking vehicles for the sole purpose of displaying them for private sale. The congregation of these vehicles is also creating vehicular and pedestrian traffic hazards and traffic congestion along these streets. Motion recommends that the City Attorney prepare and present an ordinance to prohibit parking of vehicles, displaying a For Sale sign or placard advertising their private sale, along the 1900 - 2200 blocks of 10th Avenue. Council referred Motion to the Transportation and Budget and Finance Committees for consideration.

At its meeting held September 26, 2018, the Transportation Committee conducted a public hearing. At this time, a representative of the 10th Council District Office stated that an individual sells vehicles parked along the 1900 - 2200 blocks of 10th Avenue. As many as 20 vehicles have been parked at one time, creating nuisance and hazardous conditions and leaving no parking for area residents. A representative of the City Attorney stated that the necessary findings have been made to prepare the ordinance. Committee recommended that Council approve Motion's recommendation.
