Subject: Concession and Lease Agreements with the following seven (7) rental car companies:

- 1. Avis Budget Car Rental, LLC;
- 2. Enterprise Rent-A-Car Company of Los Angeles, LLC;
- 3. The Hertz Corporation;
- 4. Fox Rent A Car, Inc.;
- 5. Advantage Opco, LLC dba Advantage Rent A Car;
- 6. DR Car Rental, Inc.;
- 7. Sixt Rent a Car, LLC

Pursuant to Section 606 of the City Charter, enclosed for your approval are seven (7) Concession and Lease Agreements, approved by the Board of Airport Commissioners at its August 16, 2018 meeting. There is no impact to the General Fund.

**RECOMMENDATIONS FOR CITY COUNCIL:** 

- 1. Adopt the determination by said Board that the award is exempt from the California Environmental Quality Act (CEQA) pursuant to Article II Section 2(i) of the Los Angeles City CEQA Guidelines. The Los Angeles International Airport (LAX) Landside Access Modernization Program (LAMP) Environmental Impact Report (EIR) [ENV-2016-3391-EIR] was certified by the Board for the Project on March 2, 2017 (Resolution 26185), and certified and adopted by the Los Angeles City Council on June 7, 2017. The action is within the scope of that certified EIR and does not include any changes to the LAX LAMP project that would require further review under CEQA pursuant to Public Resources Code § 21166 and CEQA Guidelines § 15162.
- 2. Approve the seven (7) Concession and Lease Agreements for operation of rental car concession and lease of certain space at the Consolidated Rental Car facility at LAX.
- Concur with said Board's action on August 16, 2018, by Resolution 26583, authorizing the Chief Executive Officer of Los Angeles World Airports to execute said seven (7) Concession and Lease Agreements.
