SUBJECT: UNIMPROVED MEDIAN ISLAND MAINTENANCE (CF 18-0879)

As directed by the City Council, the Bureau of Street Services (StreetsLA) is submitting this report on the resources and staffing necessary to maintain and clean the City's more than four million square feet of unimproved median islands.

There are two different classes of median islands within the public right of way: improved and unimproved. Improved median islands have an irrigation system: currently StreetsLA maintains more than 10 million square feet of improved median islands using contractors.

Unimproved median islands do not have an irrigation system, and generally fall within the following subtypes:

- Medians with non-irrigated trees and/or plants
- Medians made of concrete
- Medians with concrete curbing around an asphalt center

The City's more than 4 million square feet of unimproved medians currently do not receive regular maintenance, as the StreetsLA staff positions devoted to that function were deleted during the budget crisis of 2010 to 2012. Maintenance of the unimproved median islands consists of removing unwanted vegetation growth (weeds) litter and other debris. In response to the Council motion, StreetsLA proposes the following staff and equipment in order to provide quarterly maintenance of each unimproved median island panel, with additional visits as needed on a case-by-case basis after rainstorms produce a new crop of weeds.
