# **SUBJECT**:

Roscoe Boulevard from West of Quiet Hills Court to its Westerly Terminus – Name Change to Sterling Ranch Road

### **RECOMMENDATIONS:**

# **DISCUSSION**:

The petitioner, Centex Homes, is requesting the City to change the name of Roscoe Boulevard from West of Quiet Hills Court to its Westerly Terminus as shown colored red on the attached Exhibit "C", and to change and establish it as Sterling Ranch Road.

The Street Name Change Application states "The reason the name change/establishment is: Roscoe Blvd. is a very long street and dead-ends within the project boundary. Changing the street name to match the project would create a greater sense of place".

Roscoe Boulevard is classified as a Boulevard II per Mobility Plan 2035; however, this classification ends at Valley Circle Boulevard. Westerly of Valley Circle Boulevard, the street is classified as a Local Street. The change in width as well as the change in neighborhood character provides a noticeable change in the appearance and alignment of the street. This change creates a natural break which allows for the street name change. Additionally, the applicant has constructed improvements which emphasize the change of the street and create a natural calming effect to reduce travel speeds. Approval of the name change will emphasize the change in type of street thus emphasizing lower and safer traffic in this residential and open space area.

The properties adjoining the portion of Roscoe Boulevard proposed to be changed to Sterling Ranch Road are newly developed with new homes proposed to be built on them.

The abutting property owners were notified of the proposal for the name change of Roscoe Boulevard to Sterling Ranch Road.

There was one objection response dated May 12, 2017, from Alezar Rassibi, the owner at 8250 Quiet Hills Court. His objection stated, "Keep the same street name."

Upon adoption of the Ordinance by the City Council, the adjoining property owners and concerned agencies will be notified of the street name change.
