

ORDINANCE NO. 185723

An ordinance of the City of Los Angeles abandoning all proceedings relating to the improvement of **SUNSET BOULEVARD AND ARGYLE AVENUE Lighting District**, as contemplated by Ordinance No. 185553 and repealing that ordinance.

**THE PEOPLE OF THE CITY OF LOS ANGELES  
DO ORDAIN AS FOLLOWS:**

Section 1. All proceedings relating to the improvements contemplated by Ordinance of Intention No. 185553 are hereby abandoned.

Sec. 2. Ordinance No. 185553 approved May 23, 2018 is hereby repealed.

Sec. 3. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
