RESOLUTION NO. 18-8338 - PROPOSED PERMANENT ORDER AMENDING PORT OF LOS ANGELES TARIFF NO. 4, SECTION TWO, ITEM NO. 255 - "FURNISHING REQUIRED

DOCUMENTS" IN SUPPORT OF THE PORT'S COMMON USER DATA PORTAL

Pursuant to Section 653(a) of the City Charter, enclosed for your approval is Resolution No. 18-8338 authorizing proposed Permanent Order No. 18-7247, along with the corresponding ordinance to amend Port of Los Angeles Tariff No. 4, Section Two, Item No. 255 "Furnishing Required Documents"; which was approved at the August 23, 2018 meeting of the Board of Harbor Commissioners. The proposed Tariff amendment would add a requirement that Marine Terminal Operators participating in the Ocean Common Carrier Incentive Program electronically transmit to the City of Los Angeles Harbor Department specific information on containers handled at the Port of Los Angeles. This Tariff amendment supports the Harbor Department's first-of-its-kind common user Portal development by providing a single information window to support enhanced maritime supply chain performance. There is no impact to the General Fund.

RECOMMENDATION FOR CITY COUNCIL:

- ADOPT the determination by the Board of Harbor Commissioners (Board) that the proposed action is 1. administratively exempt from the requirements of the California Environmental Quality Act (CEQA) in accordance with Article II, Section 2(f) of the Los Angeles City CEQA Guidelines.
- 2. APPROVE Harbor Department Resolution No. 18-8338 authorizing proposed Permanent Order No. 18-7247, along with the corresponding ordinance to amend Port of Los Angeles Tariff No. 4, Section Two, Item No. 255 "Furnishing Required Documents"; and
- Return to the Board of Harbor Commissioners for further processing. 3.
