I am unable to attend the hearing downtown on the 24th regarding the parking permits pending for Monument Street. I would in lieu of my personal attendance like to submit to you my support of the permits via this email.

Residents of the lower Alphabet Streets in Pacific Palisades have had our lives greatly altered with the Caruso Project; Palisades Village having been built adjacent to a neighborhood. Monument Street and the lower Alphabets are suffering greatly due to the parking issues brought on by employees and other people using the mall who refuse to use the parking lot.

We cannot find parking on our streets now for our own cars, nor parking for any guests coming to our homes. We can barely put our trashcans out on Mondays, as we cannot find curb space, cars are parked nose to tail on our streets all day and well into the night.

We desperately need relief and the parking permits will give us that. We would hope for "permit only" parking 24/7 on Monument, but we will take whatever parameters the permits will allow us at this point.

We hope that with the overwhelming support shown by petition signatures that Monument Street had that we will be issued our permits.
