Dear Mr. Bonin,

I am writing this email to BEG you for parking permits for Monument Street in the Palisades.

I am deeply concerned about the parking issue as I live at 1115 Monument Street, only four houses up from the new development.

As it stands now, our street is packed from top to bottom, which is a hassle for us residents that live there in that we can never invite people over, nor move our cars to the street because there just isn't space. This is most true for those of us who live on lower half of the 1100 block of Monument. Caruso customers have parked blocking parts of our driveway, and have squeezed into spots so tight next to our car on the street that they have scratched our bumper.

There is a constant flow of Caruso guests parking on our street and walking to the village, especially on the weekends during the day and early evening. Even my good friends tell me that it is just easier to park on our street than to bother with the Caruso parking garage. Most of them don't mind paying for parking, it is just faster to park on our street, so the efforts to make parking cheaper are not convincing my friends to park in his lot. The only thing that would prevent them from parking on our street would be permits.

At night, I am constantly hearing people chat with their friends as they walk to their cars at 10-11pm, when I am trying to sleep. I inevitably am picking up trash from my front lawn from Caruso customers who traipse on my lawn (due to the lack of sidewalks on our side of the street).

The constant flow of people walking by my house all weekend bothers me in that my kids always play outside and there are a lot of people coming and going right outside our gate, even people sitting in their cars talking on the phone and playing music loudly. It is nerve racking for me to have so many strangers in close proximity to my young children. In addition the massive amount of traffic going up and down our street is making it even more dangerous for our kids to play outside when an errant ball flies into the street while they are playing that they may need to retrieve. Monument in particular is a wide street so when all these extra cars are driving looking for spots, they don't tend to drive slow. I want my kids to be able to play outside with some freedom, safety and security in their own front yard.

I desperately want permits for our street and would imagine that other close neighbors feel the same. As it stands now, there are many times when I feel like if we don't get parking permits we may just want to move. My preference would be to have parking for permit holders only all the time, day or night. The weekend days are the worst with the most Caruso customer and employee parking. So even if we don't have permit parking during the day during the week, I would hope for the weekend, though I understand that may not be possible.

As an aside, the farmers market would be even more disastrous for us if it is moved back to Swarthmore. And I used to love having it close by.

I just wanted to express my concerns and was hoping that you could take them into consideration.

Thank you so much for your time and effort that you put in to making our community the best it can be.

I'm sorry to bother you again, but I would like to prevail upon those of you who are looking forward to some relief to the parking issues we have had put upon us by the opening of the new Village to PLEASE take the time today to send a note in support of the parking permits

to Mike Bonin. The process is well underway, but the final hurdle will be met in a public hearing on Wednesday October 24th downtown.

I suspect many, if not most of us will not be able to attend that meeting in support of Bonin as he speaks on our behalf. If you will take the time to write a note of support stating that in lieu of your attendance that you are submitting your support in writing, we are hoping this will add weight to the case.

If we do not pass this hearing, the permits will probably not be issued. Please try not to publicize this meeting to anyone off the street as there is significant opposition to the permits from the upper Alphabets because they think it will push the parking up their way.

Hello Neighbors, (if you know of anyone not on this list, please advise)

I have been asked to forward the email below from Sue Kohl to the neighborhood regarding an upcoming meeting which is apparently the final phase of the permit parking process. Realizing that this is downtown and on a week day, I would encourage you to send a note of support to Mike Bonin's office if you cannot attend. Perhaps he can use those notes in lieu of attendance at the hearing. You can contact Bonin through his website.

As an aside, depending on what your personal feelings are about the possibility of the Farmer's Market returning to Swarthmore, I would also like to encourage you to send a note to Rick Caruso and also to Mike Bonin about this. The decision has not been made. There is a movement afoot among neighbors to move the market to Antioch or Via across Sunset to keep it from adding to the already tense parking situations that the lower Alphabets have been experiencing since the opening of the Village. Many people also prefer it to stay at Pali High because the market can support many more vendors, there is ample parking and the fees go directly to the school as much needed revenue. Please know that the parkinguopx permits will have no effect on the weekends until after 6:00 p.m. I'm told, so Monument will be a parking lot if the market returns to Swarthmore, even if Caruso promises free parking during market hours in his lot. We have clearly seen that enough people prefer to park on the lower Alphabets than to use the structure regardless.
