

ORDINANCE N 1.85973

An Ordinance amending Ordinance No. 108,684 establishing a Building Line.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section ___. Ordinance No. 108,684; entitled ... An Ordinance ordering the establishment of a building line on the eastern side of DE SOTO AVENUE on Lot A, Tract PM 3945...was passed by the Council of the City of Los Angeles...is hereby amended by repealing the provisions establishing the building line on that portion of the eastern side of DE SOTO AVENUE, as depicted on the following diagram:







Sec. XX. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.

Pursuant to Section 558 of the City Charter, the City Planning Commission on **September 27**, **2018** recommends this ordinance **BE ADOPTED** by the City Council.
