An Ordinance ordering the establishment of a building line on the eastern side of DE SOTO AVENUE on Lot A, Tract PM 3945...was passed by the Council of the City of Los Angeles...is hereby amended by repealing the provisions establishing the building line on that portion of the eastern side of DE SOTO AVENUE, as depicted on the following diagram:

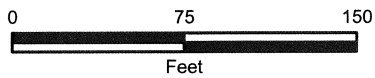

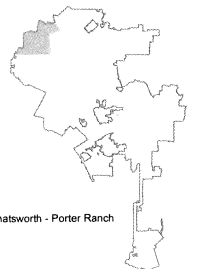


