Recommendations for Council action, as initiated by Motion (Rodriguez-Martinez):

  - a. Waive the administrative fee of \$1,304, and confirm the total assessment of \$8,500 for the parcel identified as APN 5572034012, situs address 7131 Senalda Road.
  - b. Waive the administrative fee of \$1,304, and confirm the total assessment of \$11,900.00 for the parcel identified as APN 2278023004, situs address 3650 Stone Canyon Avenue.
  - c. Waive the administrative fee of \$1,304 and confirm the total assessment cost in the amount of \$4,8000 for the parcel identified as APN 5430015005, situs address 3834 Clayton Avenue.
  - d. Waive the administrative fee of \$1,304, reduce the cost of clearance by \$12,850, and confirm the total assessment of \$29,650 for the parcel identified as APN 4415023009, situs address 16970 West Sunset Boulevard.
  - e. Waive the administrative fee of \$1,304 and confirm the total assessment cost in the amount of \$12,500 for the parcel identified as APN 5302010026
  - f. Waive the administrative fee of \$1,304, reduce the cost of clearance by \$1,495, and confirm the total assessment of \$1,495 for the parcel identified as APN 5306009030, situs address 3932 North Randolph Avenue.
  - g. Waive the administrative fee of \$1,304 and confirm the total assessment cost in the amount of \$2,2000 for the parcel identified as APN 5443007005, situs address 2360 North Fellowship Parkway.
