The Pipeline Franchise Revenue portion of the Real Property Trust Fund provides funding for street and sidewalk infrastructure improvements within each Council District.

Over the last year, Council Districts 2 and 4 have made over a dozen requests for homeless outreach and encampment cleanups at and around the SE Corner of Coldwater Canyon Ave. and Chandler Blvd. Both City and County Departments, including Metro, have used a considerable amount of resources and staff time to help address the concerns of the neighborhood.

Seeing that this area has had continuous problems, Metro and both Council offices would like to take a proactive approach and close off any openings to the City's properties that lead to the establishment of encampments in the area. The estimated cost for the project would cover labor and material for a wrought iron fence with a gate through a vendor with which Metro contracts

This effort is of special benefit for the residents of the City and for CD-2 and CD-4 and deserves financial assistance from the City.

Sufficient funds are available in the Pipeline Franchise Revenue portion of the Council District 2 and the Council District 4 Real Property Trust Funds for this purpose.

I THEREFORE MOVE that \$10,000 in the Pipeline Franchise Revenue portion of the Council District 2 Real Property Trust Fund No. 684-14 AND \$10,000 in the Pipeline Franchise Revenue portion of the Council District 4 Real Property Trust Fund No. 686-14 [TOTAL: \$20,000] be transferred / appropriated to a new Account in the Engineering Special Services Fund No. 682-50, entitled "Coldwater - Chandler Fencing" for safety fencing in the wash beneath the busway at Coldwater and Chandler (SE Corner of Coldwater Canyon Ave. and Chandler Blvd.), as further detailed in the text of this Motion.

I FURTHER MOVE that the Bureau of Engineering be directed / authorized to prepare, process and execute the necessary document(s) with, and the Controller be directed to provide such instructions as necessary to effectuate this request, and/or direct payment(s) in an amount up to \$20,000 to Ace Fence Co., or any other agency, organization, or entity, as appropriate for the above purpose, subject to the approval of the City Attorney, if needed.

I FURTHER MOVE that the City Engineer be directed and authorized to enter into a Letter of Agreement with Metro regarding maintenance of the fence, and to issue a no-fee encroachment permit or revocable permit for the installation of the fence.
