In my small twelve unit rent stabilized building in Hollywood we had 7 airbnb landlords that made a complete nightmare to live in with constant calls to the police with the nonstop noise, violent confrontations among drug traffickers, domestic violence etc. It took two years to get them all out with the last two just going in the last two weeks. Not a single one actually lived here and that will absolutely be the case of this ordinance passes. The city does not have either the infrastructure or the money to provide proper oversight. Meanwhile we're in the middle of a gigantic housing crisis. Families and working people could have been living in those units.
