NOW, THEREFORE, the Los Angeles City Council hereby finds, determines, and declares that the total number of votes cast for and against Charter Amendment EE at the Special Municipal Election by the qualified voters was 1,153,268, as set forth in the certification of the Los Angeles City Clerk and that the measure, as proposed by Resolution of the Los Angeles City Council, is hereby declared to have been approved by a majority of the voters voting thereon.
