I MOVE that the matter of ORDINANCE SECOND CONSIDERATION relative to submitting to the voters, a proposed special tax proposition on various cannabis-related activities, and calling a Special Election on the proposition and consolidating it with the State General Election to be held on November 6, 2018, Item 20 on today's Council Agenda (C.F. 18-1800-S2), BE AMENDED as follows:

- 1. RECEIVE AND FILE the pending election ordinance and ADOPT the attached resolution rescinding the proposed ballot measure.
- 2. INSTRUCT the Chief Legislative Analyst (CLA) and the City Administrative Officer (CAO), with the assistance of the Department of Cannabis Regulation (DCR), the Mayor's Office, the Chair of the Budget & Finance Committee, and the Chair of the Rules, Elections, & Intergovernmental Relations Committee, to report back in 45 days with a proposed budget policy to provide ongoing and sustained funding for DCR programming; illegal enforcement operations; and child and youth development, prevention, and Science, Technology, Engineering, and Mathematics (STEM) education.
- 3. INSTRUCT the CLA and CAO, with the assistance of the DCR, Fire Department, Police Department, Police Commission, Department of Building & Safety, Department of City Planning, City Attorney, and the Mayor's Office, to provide a comprehensive report of all activities for the current year with respect to illegal enforcement operations, including aggregate enforcement data and cost of operations, which may also include recommendations and funding requests to provide the most effective and efficient illegal enforcement possible.
- 4. REQUEST the City Attorney, with the assistance of the DCR, to prepare and present an ordinance that would implement the Cannabis Corporate Responsibility Reports policy in similar form to the proposed ballot measure.
