1. CALL TO ORDER

President Lisa Chapman called the meeting to order at 7:04 p.m. Board members in attendance were Cyrus Baraghoush, Connie Boukidis, Sandy Brown, Lisa Chapman, Roozbeh Farahanipour, Philip Gabriel, Ann Hayman, David Lorango, Mark Rogo, Stephen Resnick, and Scott Whittle. Members excused were Marcello Robinson and Laura Winikow. A quorum was present. There were 20 stakeholders and guests present.

2. APPROVAL OF MINUTES

This agenda item was taken out of order, after agenda item 12. An addendum was added to agenda item 11 in the January 9, 2019 minutes, and the amended minutes were approved unanimously.

3. COMMENTS BY PUBLIC OFFICIALS

- A. County Supervisor Sheila Kuehl's representative Erin Schneider gave an update on legislation by the Board of Supervisors and described the recent Homeless Connect Day held in Los Feliz.
- B. SLO Chris Ragsdale gave an update on crime statistics. Year-to-date, robberies were up 15%, residential burglaries were up 35.5 % and instances of grand theft auto went up from one to seven. Two officers from West L.A. Traffic Division talked about what they do and answered questions.
- C. UCLA representative Marco Perez announced that the UC Regents will be on campus March 12th to 14th so there will be extra security during that time.
- D. U.S. Congressman Ted Lieu's representative Janet Turner announced the Congressional Institute's art contest for high school students.
- E. Mayor Garcetti's new representative, Ami Fields-Meyer, introduced himself and gave a few updates from the Mayor's office.

4. DEPARTMENT OF NEIGHBORHOOD EMPOWERMENT

DONE representative Jose Galdamez passed out copies of policy guideline updates. Jose relayed a message from Renee at the City Clerk's office that the Westwood Recreation Center is not available for WWNC's election. Another location will have to be found.

5. GENERAL PUBLIC COMMENT ON NON-AGENDA ITEMS

Two representatives from UCLA's Mobile Clinic project for the homeless would like to partner with WWNC on this. Lisa Chapman invited them to attend the next Homeless Task Force meeting and recommended contacting Donovan in Westwood Village through the BID.

6. CONNECT DAY IN WESTWOOD

- A. Proposed event for those in need and experiencing homelessness in the community County Supervisor Sheila Kuehl's representative Erin Schneider described the recent Homeless Connect Day held in Los Feliz, and explained what might be done for the upcoming event in Westwood. The tentative date is April 24, 2019.

7. TRANSIT ORIENTED COMMUNITY (TOC) ORDINANCE

- A. Discussion about the ordinance that allows developers incentives for housing developments near transit centers

CD5 Planning Deputy Hagu Soloman-Cary gave an overview of the TOC ordinance and answered question. It includes a three-tier system of developer incentives. This ordinance came about because of the passage of Measure JJJ. It was developed by the Director of City Planning and is not in the City Council's purview. These projects are by-right and override the specific plans.

8. WWNC—CALL FOR APPLICATIONS FOR VACANT SEATS

A. Discussion in regard to At Large and Homeowner Seats and when to call for applications

Lisa Chapman moved, "WWNC will not post the two vacant seats due to time constraints and will wait until election time to fill the seats unless approached by someone who is interested." Philip Gabriel seconded and the motion carried unanimously.

9. NORTH WESTWOOD NEIGHBORHOOD COUNCIL GRIEVANCES

A. Update on grievances filed against the NWWNC and next steps per conversation with Semee Park (Director of Neighborhood Councils)

President Lisa Chapman reported that she had a conversation with Semee Park, in which Lisa maintained that NWWNC's December 2018 LUPC vote should be vacated because the agenda wasn't posted and Semee claimed that even though it wasn't posted until after the meeting, it still counts. NWWNC sent the posting but DONE didn't post it until after the meeting was held. The City Attorney's position is that it is up to DONE to enforce its own policies, which means there are no checks and balances in the system. Sandy Brown will try to set up a meeting with Councilmember David Ryu in order to contact the Mayor's office about the problems with DONE.

10. LOS ANGELES HOMELESS COUNT

Lisa Chapman reported that 115 volunteers participated in the count. There was an incident in Westwood Park where a park ranger asked homeless people to leave.

11. THE AGORA PROJECT/900 HILGARD VOTE

A. The WWNC will vote yay or nay to vacate previous Agora Project/900 Hilgard item and board vote from January 9, 2019 board meeting.

Lisa Chapman and Sandy Brown spoke to Steve Houchin in the City Attorney's office and were told that vacating the vote was not required. A vote to affirm or change is sufficient.

12. THE AGORA PROJECT/900 HILGARD

A. Discussion about the Agora Project at 900 Hilgard. Possible introduction of motion to either support or not support this project. Both pro and con groups have been invited to participate in this discussion.

Afriat Consulting and Aaron Green were invited but declined to attend. Save Hilgard Avenue representative Esther Magna discussed what has transpired since the January meeting and requested that WWNC oppose the project. Four HOAs in Westwood recently passed motions opposing the project. Save Hilgard Avenue has assembled a broad coalition and will be sending a petition to CD5. Representatives from Save Hilgard Avenue attended the North Westwood Neighborhood Council (NWWNC) meeting last week. They had requested to be on NWWNC's agenda but got no response. At the meeting NWWNC board members were so rude to them that the DONE representative apologized. They also attended a USAC meeting at UCLA, where they were put on the agenda along with the Agora Project. No vote was taken at that meeting since there was no quorum.

Scott Whittle moved, “WWNC validates the vote taken at the January 9, 2019 meeting to oppose The Agora Project/900 Hilgard.” Ann Hayman seconded and the motion carried by a vote of Yes: 9, No: 0, and Abstain: 1 (David Lorango). Lisa Chapman recused herself from the vote out of an abundance of caution.

13. FULL AND FAIR FUNDING OF OUR PUBLIC SCHOOLS RESOLUTION

WHEREAS, California funds schools at roughly \$1,961 per student less than the national average, which translates to approximately \$3,462 per student when adjusted for California being a high-cost state; and WHEREAS, California trails the average of the top 10 states by almost \$7,000 in per-pupil funding; and

WHEREAS, to close opportunity and achievement gaps and create a public school system that offers consistently high levels of education, the State must provide appropriate resources to meet student need;

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2019-20 State Legislative Program SUPPORT for any legislative or administrative action that would fund California public schools at the national average or higher by the year 2020, and at a level that is equal to or above the average of the top 10 states nationally by 2025 and to maintain, at a minimum, this level of funding until otherwise decreed.
