RULES, ELECTIONS, AND INTERGOVERNMENTAL RELATIONS COMMITTEE REPORT and RESOLUTIONS relative to establishing the City's position regarding implementation of a consolidated reporting timeframe for water reporting requirements and seeking to amend the Joint Exercise of Powers Action.

Recommendations for Council action, pursuant to Resolutions (Martinez - Koretz) and (Martinez - Smith), SUBJECT TO THE CONCURRENCE OF THE MAYOR:

- ADOPT the accompanying Resolution (Martinez -Koretz) to include in the City's 2019-20 State Legislative Program, SPONSORSHIP of and/or SUPPORT for legislation that seeks to implement a consolidated reporting timeframe of either January 1st or July 1st of every year for State water reporting requirements to allow water suppliers to effectively meet the State's conservation objectives.
- ADOPT the accompanying Resolution (Martinez -Smith) to include in the City's 2019-20 State Legislative Program, SPONSORSHIP of and/or SUPPORT for legislation that seeks to amend the Joint Exercise of Powers Act in relation to financing water quality capital improvement projects to:
  - a. Remove the December 31, 2020 sunset date relative to the use of Rate Reduction Bonds.
  - b. Allow Rate Reduction Bonds to finance wastewater capital improvement projects in addition to water quality capital improvement projects.
  - c. Clarify the role of the California Pollution Control Financing Authority in the review of the Rate Reduction Bonds in order to facilitate review issuance.
  - d. Specify that Rate Reduction Bonds financing documents/resolutions are irrevocable to ensure proper securitization.

<u>Fiscal Impact Statement</u>: None submitted by the Chief Legislative Analyst (CLA). The City Administrative Officer has not completed a financial analysis of this report.

<u>Community Impact Statement</u>: None submitted.

#### <u>SUMMARY</u>

At a special meeting held on February 15, 2019, the Rules, Elections, and Intergovernmental Relations Committee considered Resolutions (Martinez - Koretz) and (Martinez - Smith) and CLA report relative to establishing the City's position to support the implementation of a consolidated reporting timeframe for water reporting requirements and to amend the Joint Exercise of Powers Action.
