The City of Los Angeles offers a reward payable at the discretion of the City Council to one or more persons in the sum of \$50,000 for information leading to the identification and apprehension of the person or persons responsible for the DEATH OF DENTON JONES, in the City of Los Angeles. On Friday, February 15, 2019, approximately 10:00 p.m., 28-year old Denton Jones and a companion were seated in his vehicle on the 400 block of South Wall Street in Historic South Central, when an unknown person or persons approached in another vehicle and began shooting at Mr. Jones' vehicle before fleeing the scene. Mr. Jones was struck by gunfire and transported to the hospital for treatment. Unfortunately, Mr. Jones did not respond to treatment and was pronounced dead later that evening. Detectives are continuing to investigate this crime, but have been unable to identify a suspect or suspects. Detectives believe a reward may compel witnesses of the public to provide information on the identity of the person or persons responsible for this crime. The person or persons responsible for this crime represent an ongoing threat to the safety of the people of Los Angeles. Unless withdrawn or paid by City Council before this offer of reward shall terminate on, and have no effect after, DECEMBER 31, 2019.

The provisions of payment and all other considerations shall be governed by Chapter 12 of Division 19 of the LAAC Code as amended by Ordinance Nos. 158157 and 160501. This offer shall be given upon the condition that all citizens' private conversations within the criminal justice system relative to this case and is not available to public officers or employees of the City, their families, persons in law enforcement or persons whose records prompted this reward.
