Upon arrival, the officers found the victim, Eduardo Garcia lying on the grass near the east side of the recreation center. Mr. Garcia had been shot in the upper torso. Five Department personnel attempted to revive Mr. Garcia, but were unsuccessful. Detectives are continuing to investigate this crime, but have been unable to identify a suspect or suspects. Detectives believe a reward may entice members of the public to provide information on the identity of the person or persons responsible for this crime. The person or persons responsible for this crime represent an ongoing threat to the safety of the people of Los Angeles. Unless withdrawn or paid by City restored action, this offer of reward shall terminate on, and have no effect after, DECEMBER 29, 2019.
