**Support for a City Ban
On Behested Payments
From Restricted Sources**

The question has been raised in City Council about the justification for any City regulation of financial donations to *nonprofit organizations* from restricted sources made at the behest of elected officials --- “behested payments” “Proposed rules for fundraising face skepticism from City Hall,” Los Angeles Times, May 28, 2019.

Example Number 1: The Mayor’s Fund for Los Angeles

If elected officials enjoy a blanket allowance to solicit behested payments for nonprofit organizations, they may soon follow the current example of the mayor, who created an independent 501 (c) (3) nonprofit.

That charity, the **Mayor’s Fund for Los Angeles**, has in a recent 15 month period received *26% of all* Ethics Commission reported behested payments (\$3,651,298 during 1/1/2018 - 3/18/2019). The Mayor’s Fund for Los Angeles then passes through to operating charities ---- nonprofits often dealing with the city’s most pressing challenge --- financial donations and garners credit for doing so.

The City cannot prohibit independent 501 (c) (3) nonprofits from receiving financial donations from restricted sources under a campaign finance reform regime (2/27/2019 Ethics Commission letter to City Council, page 12).

As currently proposed, the City shall ban elected officials from direct 1:1 solicitation of restricted sources for behested payments to nonprofits.

These elected officials can continue to raise funds for nonprofits in the fund raising world of Los Angeles --- even for a nonprofit they lead --- without a cloud over their activity.

Please consider the merits of this proposed ban in any third Ordinance as requested by Motion 23-B.

MOTION

I HEREBY MOVE that Council AMEND the Rules, Elections, and Intergovernmental Relations Committee Report, relative to prohibiting Restricted Developers and non-individuals from contributing and fundraising to City Elected Officials and candidates for City Offices and restrictions concerning behested payments, to:

REQUEST the City Attorney to remove the matter of behested payments from the Ordinances being drafted in response to Recommendation Nos. 1 and 2 and to draft a separate (third) Ordinance that addresses behested payments.

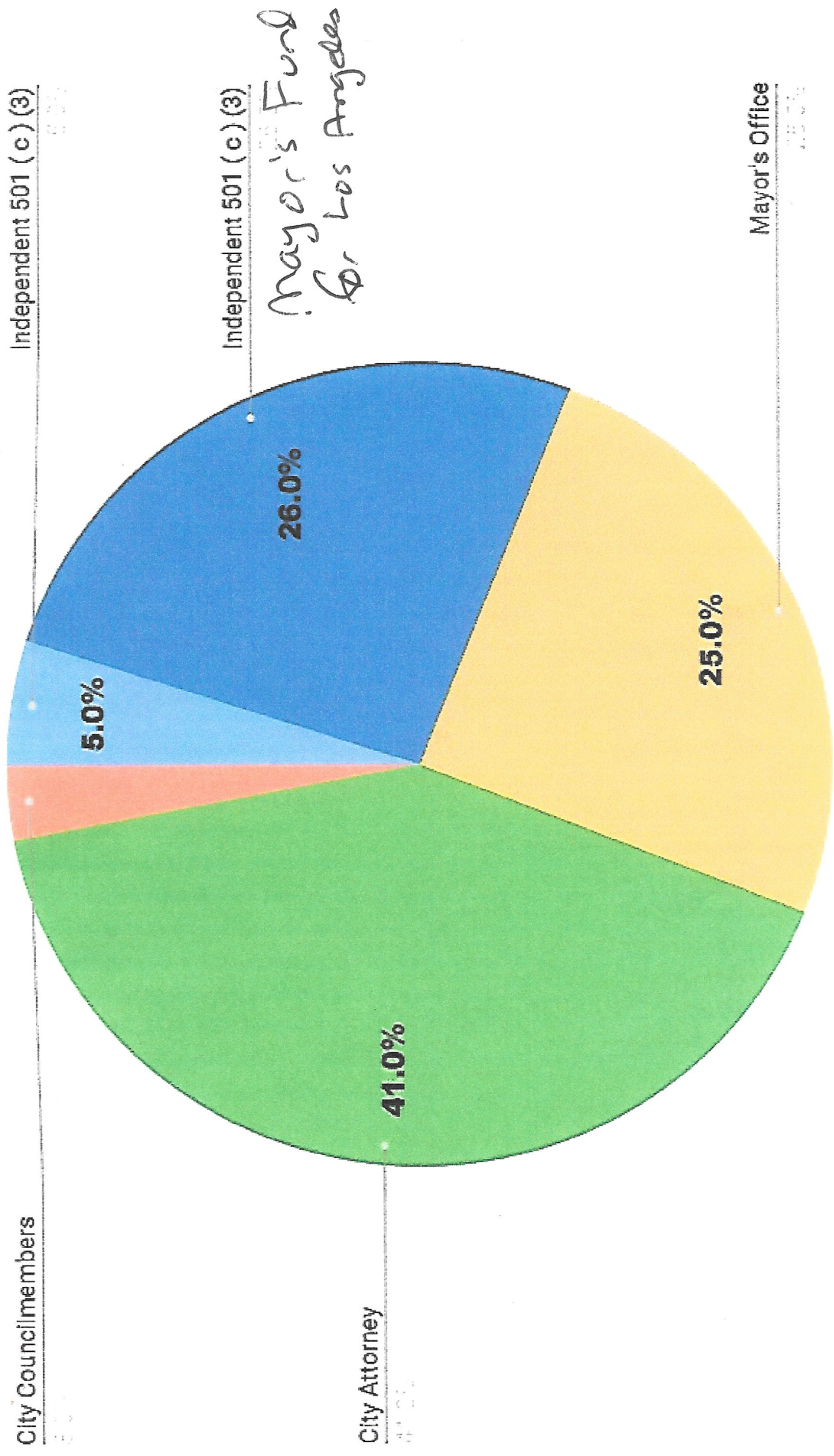

Dear Councilmembers Ryu and Bonin:

On May 9, 2019, Pacific Palisades Community Council (PPCC) unanimously passed the following motion in support of the above referenced Council File (with clarifications), as recommended by the Westside Regional Alliance of Councils (WRAC):

“Pacific Palisades Community Council supports Council Member David Ryu’s motion ([CF 19-0046](#)) and its prohibition on developer and contractor contributions to City elected officials with the following clarifications:

- i. Contributions shall be prohibited to the mayor, city councilmembers, controller, city attorney, and all PACs and non-profits that hold fundraisers or make contributions for those elected officials;*
- ii. Contributions shall be prohibited for 1 year prior to submittal of a development application (those contributions prior to submittal shall be returned) and for 1 year after a development approval and its subsequent issuance of certificate of occupancy;*
- iii. Contributions shall be prohibited from all financiers, developers, applicants, land owners, architects, engineers, contractors and subcontractors, and all employees and spouses of those employees of those firms; and*
- iv. The City Ethics Commission shall be responsible for enforcing the ordinance.”*

We urge that the motion be adopted with the inclusion of the above clarifications.
