DRAFT ALTERNATIVE ORDINANCE B AMENDING ARTICLES 9.5 AND 9.7 OF CHAPTER IV OF THE LOS ANGELES MUNICIPAL CODE TO RESTRICT DEVELOPER CAMPAIGN CONTRIBUTIONS WITH PRIMARY ELECTION 2022 OPERATIVE DATE

Honorable Members:

On May 23, 2019, the City Council made a number of instructions with respect to proposed amendments to the Los Angeles Municipal Code regarding campaign contributions. Council's instructions requested that the ordinance not be operative until after the 2020 election cycle and that the Ethics Commission create, update, and regularly publish a list of persons restricted from making contributions in an electronic database. On September 17, 2019, our Office transmitted draft Ordinance B, which included an operative date beginning with the general election of 2022, given the Ethics Commission's comments that an electronic filing and database system would likely not be available until that time and the concern that candidates may not have an accessible list of prohibited persons until that time.

In order to provide the City Council with the option of enacting an ordinance with an earlier operative date that is also consistent with the Council's May 23, 2019, instructions, this Office has prepared and now transmits for your consideration an The Honorable City Council of the City of Los Angeles Page 2

alternative draft ordinance substantially the same as Ordinance B, approved as to form and legality. This draft ordinance's only difference with draft Ordinance B is the earlier operative date and a technical amendment regarding disclosure filing.

This alternative draft ordinance would implement the campaign restrictions with the operative date beginning with the first date to file fundraising papers for the primary 2022 election, currently March 2020. The enclosed draft ordinance also eliminates the requirement that applicants use an electronic database created by the Ethics Commission, but instead requires the applicants to file the information with the Ethics Commission. As already provided in the existing campaign finance ordinance, the method of filing would be determined by the Ethics Commission and could include paper or electronic filing. The Council instruction still requires the Ethics Commission to publish and regularly update the list of restricted contributors on a publicly accessible electronic database.
