I am writing in support of Agenda Item #19-0145. As a resident and City Councilwoman for the City of Simi Valley my residents and I are directly impacted by the Department of Energy's failure to follow through on their promise to clean up the nuclear meltdown and toxic chemicals that Santa Susana Field Lab have failed to clean up. As you know this past Fall's Woolsey fire started at Santa Susana Field Lab and the toxic fumes from the chemicals that have never been cleaned up caused many of our Simi Valley and West San Fernando Valley residents with asthma to go to the emergency room due to serious respiratory conditions. As an asthmatic myself I had to go to the hospital at 2am because I had problems breathing even after having taken all of my inhalers and several at home breathing treatments. When I arrived at the hospital there were at least 10 other people with the same respiratory issues. I am also a PE teacher at John R. Wooden High School in Reseda where I had several students who reside in Canoga Park, West Hills and Chatsworth who also had many respiratory issues during the fires. As a cancer survivor myself I am very concerned about the toxins that have yet to be removed by the Department of Energy or the California Department of Toxic Substances Control despite their promises to have these chemicals cleaned up by 2017. On behalf of my students who live in the West San Fernando Valley and the residents of Simi Valley who are detrimentally impacted by the failure to clean up the Santa Susana Field Lab I urge you to be our voice, our defenders and our advocates.

It's been brought to my attention that the City, specifically the Budget and Finance Committee, will be voting today as to whether or not to approve an expenditure of \$600,000 to retain legal counsel regarding enforcement of the U.S. Department of Energy's promise to clean up the Santa Susana Field Lab. It is my understanding that the City has already approved this motion to retain legal counsel and that the natural (and necessary) next step is to continue supporting the cleanup effort with this financing motion. As a resident of Conejo Valley, born and raised — and currently raising my own family here — I have seen the devastating effects the SSFL site has wreaked upon our community and the immediate surrounding areas. Many are still mourning the loss of sweet Hazel Hammerstein, who passed after a long, lengthy battle with Neuroblastoma last year. So many families in the immediate surrounding area of the SSFL site have experienced abnormal cancer rates, putting our children at risk each and every day. With the recent fires, it's more important than ever to help protect our community from the radioactive and toxic contamination that still exists at the site. While \$600,000 is no small number, when it breaks down to just \$0.20c per child, this doesn't appear to be asking too much to help ensure the safety and health of families in the community are protected.

Dear City Clerk and Honorable Councilmember Blumenfield:

I am a constituent of Councilmember Blumenfield in Woodland Hills.

I am writing this morning to urge the councilmember to vote in SUPPORT of council file 19-0145. The city of Los Angeles should allocate the appropriate funds to retain a law firm to work to prosecute the necessary legal action to ensure that the Santa Susana Field Laboratory (SSFL) is remediated in a manner that is consistent with the 2010 Administrative Order on Consent.

By approving this motion today, the Budget and Finance Committee will reflect the City's stated desire to retain legal counsel in this matter and to allocate these funds.

In the wake of the devastating Woolsey Fire, which was ignited on Boeing's property on the SSFL site, Angelenos deserve protection from further exposure to the toxic contamination situated on the SSFL site. In a matter of hours after that conflagration began, smoke was already wafting over Woodland Hills, having traveled south, south by southwest and south by southeast. I know, because I was in Canoga Park for a few hours that afternoon and observed as the smoke's course was pushed southward by very powerful Santa Ana winds.

Children constitute a class of sensitive receptors to toxic contamination, particularly airborne toxins. When the 3 million children in the City are figured into the equation, this budget allocation amounts to just 20 cents per child. That is a tiny price to pay for a result that benefits millions of children.

Moreover, under the new CalEPA secretary, Mr. Jared Blumenfeld, the state Department of Toxic Substances Control has urged the federal Department of Energy that it must comply with the 2010 consent agreement.

A citizens' petition calling for full cleanup of the SSFL site has garnered more than 600,000 signatures. The city of Los Angeles must stand up and fight for us! This is a matter of environmental justice.

Some of you have been to the West Hills Neighborhood Council (WHNC). Others have sent their staff members to these meetings.

In August 2011, I was the Environment Committee Chair of the West Hills Neighborhood Council as well as their Public Health Committee Chair.

I prepared the attached PowerPoint presentation to give to the WHNC in their space at Chaminade High School. Historically, we had used the projector in that room, and I had no reason to believe that projector would not work that night. So I only had one hard copy of my power point that day to present. The projector did not work that evening, and I had to read my PowerPoint presentation to the Board and the stakeholders who were present.

I am attaching that PowerPoint which I have made only grammatical (alignment or punctuation) changes to; I pulled a redundant slide and a blank page; and I have added my name to it, etc, to submit this to you.

I am submitting the Resolution that was voted upon that evening. I am attaching the minutes of that meeting that show there was one change to my submitted resolution.

At the time, that Resolution was supposed to be submitted as a Community Impact Statement. I do not know if it was ever attached to a file - that was back in 2011. If you note, the line at the bottom of the resolution shows that this was the Final version of the Resolution - that one line was removed as voted upon by the WHNC.

I wanted you to know the level in which I review documents, and I presented those documents to the WHNC prior to their taking action. I also presented those documents as a Technical stakeholder with

DTSC, the Federal EPA, the Los Angeles Regional Water Quality Control Board, a Stakeholder for "Groundwater U" sponsored by DTSC, a stakeholder at DTSC meetings related to The Boeing Company, NASA SSFL, and the DOE SSFL. I also was a member of the DOE Soil Treatability Investigation Group (STIG), a NASA Section 106 Consulting Party, and I am currently a DOE SSFL Section 106 Consulting Party.



The History of the Santa Susana Field Laboratory and Why We Are Talking Today

The SSFL must be thought of in its military context.

- The site was designed as a remote site for research and development after World War II.
- At that time, the Responsible Parties were not The Boeing Company, NASA, and the Department of Energy.
- NASA and the Department of Energy did not exist in 1947 when this site was purchased.

.

- This site was used for missile technology after the United States captured many Germans who had been doing that kind of research during World War II.
- Some of the research would later be used for engine tests – first for the Air Force and later for NASA.
- Most of the TCE in the ground went into the ground when the Air Force was using the SSFL site – prior to 1961 – before NASA took possession.

Nuclear research was the result of Eisenhower's "Atoms for Peace" program.

- The nuclear reactors at the site were all of a very small scale compared to those that are used for nuclear power today.
- One reactor SNAP 10 was designed at Santa Susana and taken to Vandenberg Air Force base where it was launched into space.

The Sodium Reactor Experiment (SRE) – the world's first nuclear reactor used for commercial energy purposes; it was used to produce some energy for the City of Moorpark, although not designed expressly for that purpose.

- •It was designed to see how a sodium cooled graphite moderator would hold up in a larger scale facility.
- It was specifically designed so that it would not be under pressure and explode as the reactors in Fukushima have in recent months.

PUTTING THINGS IN PERSPECTIVE

There is no way to compare a sodium cooled graphite moderated 20 MW thermal, 6.5 MW energy reactor to those in Japan that average 1300 – 3000 MW thermal, and roughly 440 MW to 1000 MW energy. Those reactors are water boiler reactors, they did create pressure, and they also had their spent fuel stored in pools inside of their reactor housing.

In August 2009, the Department of Energy had a 7 hour Workshop on the SRE.

- The conclusion of a balanced panel of nuclear physicists was that only the gases Xenon and Krypton were released in the incident in July 1959 when the SRE reactor overheated.
- According to these physicists, there was no harm to the community from that one incident then, and there is no known residual contamination from that one incident today.

TODAY

- AREA IV, which is the area for which the DOE is responsible for cleanup, has had close to 275 structures in its almost 60 year history.
- About 25 structures remain.
- Two facilities the Radiological Materials
 Handling Facility and a SNAP building have the most residual radiological contamination on the site.
- They are fenced and restricted from access.
- Some WHNC members toured the SNAP building a few years ago.
- These site tours enable us to see what was there (by historic maps, videos, and photos), and what is left there today.

The ongoing question related to this site is: Is this site causing any harm to the West Hills community today?

- In December of 2010, we had Dr. Mack, an epidemiologist that is an expert on cancer in Los Angeles and Ventura counties tell us that we have no elevated incidence of cancer in West Hills.
- We have no cancer clusters.
- He could not correlate any cancers with any particular facility – not only the Santa Susana Field Laboratory – but no other facilities in all of Los Angeles County.

At the July 2011 WHNC Board meeting, we had Tom Seckington of DTSC speak about groundwater.

- When he was asked if he believed that groundwater had migrated from below the site to West Hills, he said that he "...was unable to answer that question..."
- they are still sampling seeps and springs to see if the contaminants have migrated.
- Public health and public safety are the primary reasons that we put so much time into studying SSFL.
- We all want the site to be cleaned up in a manner that is protective of our health offsite as well as for people and animals that visit that site in the future.

- To address public health and public safety as well as to protect the environment, we need to have an Environmental Impact Statement done for AREA IV of the Santa Susana Field Laboratory, which is currently under a federal court order.
- NASA's property will have an EIS done on a voluntary basis under NEPA – the National Environmental Protection Act.
- Finally, all of SSFL will have environmental studies done under CEQA – the California Environmental Quality Act.

Key dates and key issues

- DOE has performed an Environmental Assessment under NEPA.)
- 2) LA City is a plaintiff in that DOE lawsuit; federal Judge Samuel Conti found DOE in violation of NEPA, and he ordered the DOE to complete a full EIS. He also retained jurisdiction until it was completed.
- 3)) The EIS has already been funded, and the process for starting the EIS began on July 19, 2007, when the DOE announced: "DOE Announces Intent to Perform EIS ".
- 4) The Data Gap Analysis and the Scoping Process for the DOE EIS began in 2008.

5) Why are we addressing the DOE EIS? →

To resolve conflicts between the AOC and the EIS->

So that progress will continue...in a safe manner :

The EIS requirements should be modified to allow for all parties to agree

- A) to AOC cleanup/mitigation continuation, and
- B) to allow building destruction/site analysis as required to determine characterization (contamination levels under the remaining buildings, dumps, and related sites), and
- C) to abide by the findings of a completed EIS and a California EIR Process, submitted by CA DTSC, related to analysis and characterization of areas and types of contamination to be mitigated, methods and procedures for remediation of contamination, and
- D) to the standards required by the Nine Balancing Criteria and that future potential usage with the Nine Balancing Criteria used as a guideline for the EIS, EIR and AOC AND
- E) that continued monitoring of the surface water, groundwater, air, soil, and structures, and runoffs to ensure proper human and animal/wildlife safety be enforced.

Key dates and key issues

- 6) We should also point out that an archaeologist told the PPG meeting that CEPA and NEPA documents can be done at the same time, and that the EIS should not delay the cleanup any more than CEQA will. John Jones of the DOE stated at the PPG that the DOE is obligated to follow NEPA.
- 7) The only thing holding up the completion of the EIS is the complete characterization that is in process now by the EPA, CDM (the DOE's contractor), and DTSC.
- 8) 8) LA City Council voted in Closed Session regarding the Conflict between the AOC and the EIS. We do not know their decision. We would like WHNC to be in an advisory role to the City of Los Angeles regarding that Conflict.

- 9) Chris Rowe was told by Council member Hahn that we need to file Community Impact Statements from Our Neighborhood Councils elected officials have asked to have the WHNC make a formal comment rather than hear individual comments.
- 10) Also missing from the AOC are the 9 Balancing Criteria.

- 1. Overall protection of human health and the environment
- 2. Compliance with Applicable, Relevant and Appropriate Requirements
- 3. Long-term effectiveness and permanence
- 4. Reduction of toxicity, mobility, or volume
- 5. Short-term effectiveness
- 6. Implementability
- 7. Cost
- 8. State acceptance
- 9. Community acceptance

- 11) We would like to respectfully request that the Boeing Company reaffirm their Letter of Intent to the State
- 12) We would like to respectfully request that The Boeing Company affirm that they will not sell their SSFL property for residential use.
- 13) We would like to respectfully request NASA and GSA to make that commitment for the future use of their property to not be residential as well.
- 14) We would like to ask The Boeing Company to reaffirm from its Letter of intent to donate the land as parkland - to the State, or to the Federal Government.

- Boeing and NASA own approximately 2,850 acres of Property in Ventura County, the Department of Energy owns facilities on an approximately 90-acre portion of the site.
- 2. Boeing agrees it will clean up the Property for both radiological and chemical constituents using a risk-based approach for both human health and ecological risk receptors consistent with State law, even if NASA or DOE do not achieve the standard.
- 3. Boeing agrees to clean up the Property to levels acceptable for residential use and that protect individuals living in the vicinity of the Property.

- 4. The State agrees that the property will not be used in the future for residential, agricultural, commercial or other uses, except for park, recreational or open-space.
- Boeing agrees to maintain financial assurance mechanisms until the State certifies the Property cleaned up and transferred.
- 6. Boeing intends to donate the Property to the State and facilitate a no-cost acquisition of the NASA Property to be preserved as park land and/or open space.
- 7. Boeing intends to transfer the Property on an area-by-area basis after all soil remediation has been completed.

- 8. If the State fails to acquire either the NASA or Boeing Property, Boeing agrees to never the less achieve the residential clean-up standard.
- 9. Boeing agrees to restore the Property to an unimproved natural state prior to transfer.
- 10. The State has the right to approve land use covenants or other institutional controls necessary for approved remediation of the Property.
- 11. Boeing agrees to pay \$750,000 per year for 30 years to fund conversion of the Property to the State, first payment payable with recording of the first transfer.

- 12. Boeing waives all claims against State connected with hazardous wastes etc., known or unknown that existed or are present on Property prior to transfer.
- 13. Boeing assumes full responsibility for all costs, expenses and liabilities associated with the performance of environmental remediation of the Property.
- 14. Boeing agrees to indemnify and defend the State against all claims associated with remediation, third party claims and claims. by federal, State or local governments.
- 15. Transaction is subject to negotiation and execution of appropriate Acquisition Agreements between Boeing, the State and NASA.

- 15) We would like to respectfully request that the future use of the NASA / GSA property end use to also be parkland or open space as determined by their EIS.
- 16) We would like to request that The Boeing Company, NASA, and the Department of Energy create a fund for 30 years as is mentioned in the Boeing LOI to maintain and to monitor the air, groundwater, the surface water, the soil, and the Best Management Practices that have been implemented at the site.



Environmental Impact Statement

On July 19, 2007, the U.S Department of Energy's (DOE) Office of Environmental Management announced that it will prepare an Environmental Impact Statement (EIS) for remediation of Area IV. DOE will issue an Advance Notice of Intent to prepare an EIS and include extensive input from the local community and public as well as state and federal regulatory officials in the EIS development. DOE also notified its contractor, The Boeing Company, that cleanup activities at ETEC, which have been halted since May 24, 2007, will be stopped. DOE will restructure the existing contract with the Boeing Company to discontinue planned decontamination and decommissioning (D&D) activities The restructured contract will include surveillance, maintenance, and environmental monitoring work, including soil and groundwater characterization required under state regulations, while DOE prepares an EIS.

The Department of Energy and NASA both signed Administrative Orders on Consent (AOC) with the California Environmental Protection Agency that define the process for characterization and the cleanup end-state for portions of SSFL.

An Overview of NASA's History at SSFL

This provides information on the cleanup of MASA-administered at the Santa Susana Field Laboratory (SSFL).



The SSFL is located on 2.850 acres in the Simi northwest of downtown Los Angeles, California, in southeastern Ventura County (close to the communities of Santa Susana Knolls, Bell Canyon and Simi Valley). The facility opened in 1948 and is divided into four so-called "Administrative Areas." Most of Area I and all of Area III are owned and operated by the Boeing Company, Area II and a 41.7-acre portion of Area I owned by the U.S. Government and administered by NASA. Area IV is owned and operated by Boeing for the U.S. Department of Energy (DOE), which has long held a lease on that land.

NASA administers 451.2 acres in two areas of the Santa Susana Field Laboratory (SSFL) and has operated here since 1973, when we first acquired land from the U.S. Air Force (USAF). Prior to 1973, NASA conducted testing at SSFL in cooperation with the USAF. NASA recognizes the importance of communicating directly with the community regarding our properties, current and former operations at SSFL and the ongoing environmental cleanup taking place. Other areas are owned and operated by the Boeing Company. NASA is committed to a cleanup of the areas we administered to a level protective of public health and the environment. This literature is part of our efforts to keep you informed.

The activities conducted throughout the NASA-administered areas of the SSFL have included research, development and testing of rocket engines associated with the Apollo and Space Shuttle Programs, and for Air Force missile programs. The 41.7 acres of Area I formerly administered by the USAF (and since 1976 by NASA) were used for a Liquid Oxygen (LOX) Plant, which operated under the USAF from the early 1950s until the late 1960s. The plant's buildings and tanks were removed in the 1970s. At its peak, our other property, Area II, contained some 125 buildings and other structures, many of which have been demolished during the past three decades. It also included several ponds for containing cooling water that had been used in rocket testing. Area II was used extensively in support of Space Shuttle Main Engine activities and consisted of four testing locations, which are no longer operational.





Historical Site Assessment

The ETEC Historical Site Assessment (HSA) was completed in May 2005. The HSA is a detailed investigation of historical information from Area IV that identifies sites that may have contained regulated radioactive material. The HSA describes the final status surveys performed for those sites that have been released for unrestricted use by the appropriate regulatory agencies. Sites requiring further sampling are identified in the <u>HSA</u>.

Groundwater

DOE has installed over 50 wells in and around Area IV. Groundwater is monitored at the Santa Susana Field Laboratory program under the oversight of DTSC. Chemically impacted groundwater has been identified in conjunction with four Solid Waste Management Units, FSDS, 4056 landfill, 4059 and RMHF leachfield, as found on the above map. Radiologically impacted groundwater was found near Building 4010. Visit the tritium in groundwater page for more information about monitoring in this area.

Cleanup Status

EPA Conducts Superfund Evaluation of SSFL

U.S. Environmental Protection Agency (EPA) is conducting a Superfund Evaluation of the Santa Susana Field Laboratory (SSFL), including the site of DOE operations in Area IV.

Consent Order

On August 16, 2007, the Department of Toxic Substances Control (DTSC) issued a "Consent Order for Corrective Action" to The Boeing Company, the Department of Energy (DOE) and the National Aeronautics and Space Administration (NASA) to guide the RCRA cleanup at the SSFL.

Cleanup Status

EPA Building Survey

Between January 2000 and September 2001, EPA and its contractor, Tetra-Tech, reviewed Boeing's and DOE's final status and verification surveys of 11 prior radiological facilities that had undergone D&D survey and release. EPA and Tetra-Tech also conducted radiological surveys of 8 of these facilities.

Chemical Co-Located Sampling

DOE and DTSC have been in the field working on the chemical co-located sampling effort with EPA. Since the beginning of the co-located sampling effort several documents have been prepared by CDM, DOE's contractor and approved by DTSC. DOE is committed to keeping the community informed in a timely manner of the chemical co-located effort and all other DOE-related efforts on the site. This web page will be kept up to date with future documents and information regarding chemical co-located sampling.

Opening Business:

Co-Chair Mr. Stephen Lenske established a quorum, called the meeting to order and asked that all in attendance follow Chaminade's housekeeping rules. He also asked any stakeholders who would like to speak to please fill out a speaker card so that the appropriate amount of time can be allotted for public comment. Mr. Lenske advised that each speaker would have two (2) minutes to speak and requested that each person respect the time limit. Mr. Lenske advised that the council has been putting out a fantastic monthly e-mail newsletter. Mr. Lenske stated that if anyone has information to be included in the newsletter to please get in touch with the Communication Committee. He also advised anyone interested to sign up on the e-mail list and receive WHNC updates.

Mr. Lenske advised that a seat is available on the Board. He encouraged those in attendance to review the list of committees and consider becoming part of the Board.

Mr. Lenske advised that there has been a development that has just come to the board's attention. It is a plan to have advertising on bus benches. There was a hearing on Aug. 3, 2011 at 2 p.m., about which the West Hills Neighborhood Council received no advance notice.

Minutes – the minutes of July 6th were approved as corrected.

Treasurer Ms. Bobbi Trantafello reported that she does not have a Treasurer's Report this month. The only activity was payment on the storage unit. Ms. Trantafello advised that she is still in the process of auditing the entire year. Mr. Lenske advised that the WHNC's equipment has been

moved to a smaller storage unit and effective Aug. 1 we should see a reduction in the monthly cost.

Announcements:

Mr. Ron Rubine, Field Deputy for the 3rd Council District, provided an update on activities in the area. National Night Out on Aug. 2 was a huge success. Thirty-five million people all over the country participated in the event. There is the Clean & Green project going on, which culminates Saturday. This project involved hiring 300 kids and paying them minimum wage to clean up parkways during the summer. Councilman Zine requested that he be part of any ribbon-cutting ceremony for the installation of the West Hills street signage.

Ms. Semee Park, Field Deputy for the 12th Council District, advised that she would have Councilman Mitchell Englander's response regarding contribution to the cost of the West Hills signage in District 12 by next week.

Ms. Park stated that Councilman Englander is looking into just how much money from judgments, as the result of those prosecuted for vandalism, has been recouped. Ms. Park advised that a reception will be held at 5 p.m. on Aug. 14 at Rancho Cordillera del Norte in celebration of the completion of the first phase of the San Fernando Valley Oral History Program.

Mr. Maximillian (Max) Reyes, Senior Field Representative of State Senator Fran Pavley, was introduced. He advised that the senator has authored a bill, SB 586, on elder and dependent adult abuse. All fines for elder abuse will double under this bill.

Ms. Joanne Yvanek-Garb spoke about city redistricting. Under a new plan, the Valley could have more power. Ms. Yvanek-Garb advised that the need for a ratepayer advocate is still a hot issue.

Mr. Sol Bash advised that the Emergency Preparedness Committee plans to hold the next Emergency Preparedness Fair again at Shadow Ranch Park. The date will be between March 31 and April 7. More information will follow.

Mr. Wally Perfect gave an update on upcoming Zoning & Planning meetings. At this time, the only meeting will be the regular meeting at the 911 Call Center.

Ms. Bonnie Klea advised that she attended the meeting on the proposed development between the Topanga and Westfield Malls. Ms. Klea advised that there would be no single-family homes, but there would be a 10,000 sq. ft. community center and the developers are planning to make a presentation to the WHNC Board in September.

Presentation

Mr. Dan Brin introduced Mr. William Vietinghoff. Mr. Vietinghoff is a former engineer at the Santa Susana Field Laboratory. Mr. Vietinghoff provided a brief history of the site and its many owners.

Public Comment:

Council member Bob Brostoff expressed his concern that the revised bylaws have not been

presented for a vote to date. Mr. Brostoff stated that the bylaws were to be read at this meeting and he failed to understand the reason this has not occurred.

Council member Bonnie Klea expressed her displeasure with the new Board committee assignments and not being allowed to be a voting member of the Environmental Committee although she is a former employee of the Santa Susana Field Lab and has been an environmental activist since 1995.

Stakeholder Margery Brown stated that we are running out of time to take action regarding what is happening at the Santa Susana Field Lab.

Board member Jacquie Young advised that she too has an environmental concern. Ms. Young stated that Boeing has been sending trucks of waste from the Santa Susana Field Lab and she is wondering if there have been any accidents or spills that we have not been notified of.

Government Report

Board member Joanne Yvanek-Garb advised that she did not receive any material to be presented at this meeting from Dr. Wiseman, who was unable to attend tonight due to conflicting vacation plans.

Old Business:

02-0003 – Discussion and possible action re West Hills Street Signage

Mr. Wally Perfect advised there is nothing new and rather than take up time now there is going to be a meeting on Tuesday and he will then present the information to the board.

New Business:

11-0018 – Discussion and possible action regarding the West Hills Neighborhood Council conducting its biennial election of open Board seats in March 2012

Mr. Edwin Dockus advised the Board that the City Clerk is not running the Neighborhood Council election next March. We (WHNC) have the option of holding our own election or wait until 2013 for the City Clerk to hold the election, he said. We can hold our own election in a Town Hall meeting format and we again could work with other Neighborhood Councils. As in the past, working with other councils has lowered the cost of putting on an election.

After discussion, Mr. Dockus moved that the WHNC conduct a Town Hall election in 2012, subject to funding. Motion passed with 16 ayes and 3 nays.

11-0019 – Discussion and recommendations regarding the Santa Susana Field Lab

Ms. Chris Rowe provided an overview of the history of the Santa Susana Field Lab, the parties involved and a lawsuit regarding clean-up efforts. Ms. Rowe stated we have even heard from Dr. Mack, noted epidemiologist, who made a presentation to the Board saying he found no evidence of cancer clusters in our area. (His PowerPoint presentation can be found on the Public Health Committee page.) Ms. Rowe presented a Resolution in Support of An Environmental Impact Statement for Area IV of the Santa Susana Field Laboratory from the Environmental Committee (copy attached).

Mr. Dan Hirsch, President of Bridge the Gap, challenged information presented by Ms. Rowe. Mr. Hirsch stated that the City Council voted on the matter two months ago and unless Judge Conti gives relief in this lawsuit it will mean the end of funding for current cleanup efforts and the end of the cleanup.

Board member Bonnie Klea said she disagrees with Ms. Rowe's presentation in its entirety. She stated that every state, federal and local agency is currently involved in this cleanup effort under SB990.

Ms. Margery Brown advised that she has been on the West Hills Neighborhood Council Environment Committee from the beginning. Ms. Brown stated that the resolution presented by Ms. Rowe from the Environment Committee was only verbally presented at a committee meeting that was held on four days' notice and attendees were not given a written copy to review. Ms. Brown went on to state that even though this matter has not come before the Board, Ms. Rowe wrote to Judge Conti and represented herself as speaking for the Board.

Ms. Dorri Raskin advised that she has been an environment activist for 22 years and she opposes Ms. Rowe's recommendation.

Ms. Marie Mason stated she was very confused about the proposed resolution from the Environment Committee. She questioned taking any action that went against what the City Attorney was supporting.

Ms. Holly Huff advised that the vote taken by the West Hills Environment Committee on the resolution was close. It was not provided to the committee in writing before a vote was taken and she objected to that procedure.

Ms. Jeannne Londe stated she was puzzled and confused. Ms. Londe stated she has been involved with the Santa Susana Field Lab problem over 20 years and she has no idea what Ms. Rowe was talking about.

Mr. Ryan Moorman, Teens Against Toxins, stated that an agreement on cleanup efforts has been reached with very few objections. Mr. Moorman questioned whether it was wise to go against a recommendation of the City Attorney.

Ms. Devyu Gortnev, Teens Against Toxins, stated she is concerned about her health and that of others. She stated that the decision on cleanup efforts is affecting thousands of people.

Board member Elliot Maggin thanked Ms. Rowe for all of her work. Mr. Maggin spoke in favor of an Environmental Impact Statement because it would provide information that would be helpful in understanding a complicated issue.

Board member Sandi Bell stated that she finds it offensive that it appears that Ms. Rowe is being criticized by Board members and others in attendance that were using terrorist tactics.

Mr. Alec Uzemeck stated that he agreed with Ms. Klea and said that this cleanup issue is a very complex situation. Mr. Uzemeck stated that what is in place should be left to be completed and the council not get involved taking such action that would set the matter back.

Ms. Rowe made a motion that the Resolution be acted on by the Board. After additional discussion the vote was taken and the motion failed.

Ms. Rowe then read an eight-point recommended Resolution for the General Remediation of and Future Use of the Santa Susana Field Laboratory (copy attached).

After discussion, Board member Ms. Charlene Rothstein moved that the third item on the resolution be stricken. Motion passed without challenge from Ms. Rowe.

Board member, Mr. Bob Brostoff stated that the issue was far too complicated and that many of the board members did not understand it, and that he recommended a "no" vote on the motion.

Subsequent motions by Mr. Bob Brostoff and Mr. Wally Perfect to eliminate item numbers one and two failed.

Motion to accept Resolution as amended passed.

RESOLUTIONS FOR THE REMEDIATION OF AND FUTURE USE OF THE SANTA SUSANA FIELD LABORATORY

WHEREAS the West Hills Neighborhood Council is an advisory body to the City of Los Angeles under the City Charter and is the nearest community in the City of Los Angeles to the Santa Susana Field Laboratory site; and

WHEREAS West Hills is the community in Los Angeles that is most likely to be affected by contamination from the Santa Susana Field Laboratory site and by cleanup efforts that include truck traffic to and from the site, airborne contamination and emissions, potential groundwater contamination, and contaminates in the groundwater that may have a potential for vapor intrusion;

LET IT BE RESOLVED that:

- [1] The West Hills Neighborhood Council respectfully requests that the future use of the Santa Susana Field Laboratory not be used for residential purposes;
- [2] The West Hills Neighborhood Council encourages the use of the Nine Balancing Criteria for the remediation of the Santa Susana Field Laboratory;
- [3] The West Hills Neighborhood Council recommends ongoing monitoring of airborne emissions and dust from remediation, monitoring of surface water and groundwater, and monitoring of soils at the Santa Susana Field Laboratory site until it [DTSC]* deems that the site is cleaned according to all relevant and applicable laws;
- [4] The West Hills Neighborhood Council recommends the future use of the Santa Susana Field Laboratory as parkland or open space based upon the final characterization of the site;
- [5] The West Hills Neighborhood Council recommends the protection of some of the test stands on the NASA property if it can be done in a manner that is protective of public safety and will not impede the cleanup beneath the test stands;
- [6] The West Hills Neighborhood Council supports all environmental laws that are applicable to this site that are protective of endangered species and wildlife that uses the site as a major wildlife corridor; and
- [7] The West Hills Neighborhood Council supports all laws that are applicable for the protection of the cultural and archaeological aspects of this site, which is considered sacred to the Native American community and has archaeological sites that are on the National Register of Historic Places.

The West Hills Neighborhood Council recommends to the City Council and the City Attorney that this resolution be recorded as part of a Community Impact Statement for West Hills. The West Hills Neighborhood Council also requests that the City Attorney present this resolution with any other letters from elected officials and community groups when submitting any recommendations to the City Council or to Judge Samuel Conti or his peers relating to NRDC, Committee to Bridge the Gap, and the City of Los Angeles v the Department of Energy.

*the word DTSC was placed for clarification because the previous paragraph in the original resolution which mentioned the California Department Of Toxic Substance Control (DTSC) was voted upon by the West Hills Neighborhood Council to be removed from the resolution.

Dear Los Angeles City Council Budget and Finance Committee:

We write today as residents of Woodland Hills and as board members of Physicians for Social Responsibility-Los Angeles to express our support of item 19-0145, which authorizes the allocation of funding for outside counsel to assist in potential litigation related to the Santa Susana Field Laboratory cleanup agreements.

PSR-LA has been involved for over 30 years in efforts to cleanup SSFL, the site of a partial nuclear meltdown and numerous other accidents, spills, and releases. We strongly support the Administrative Order on Consent (AOC) that the Dept. of Energy (DOE) and the Dept. of Toxic Substances Control (DTSC) signed to clean up all of the contamination at SSFL to background levels.

This standard is of critical importance to public health. SSFL is contaminated with extremely dangerous radionuclides such as cesium-137, strontium-90, plutonium-239 and tritium. In 2012, the EPA found radiation in hundreds of samples at the site, up to 1,000 times background. Strontium-90 concentrates in bone and can cause bone cancer or leukemia. Cesium-137 is a powerful gamma emitter, capable of causing cancer in any organ. Plutonium-239 is one of the most toxic materials on earth; a few millionths of an ounce if inhaled will cause cancer with virtual 100% statistical certainty. In addition, SSFL is also polluted with hazardous chemicals such as TCE, perchlorate, dioxins, heavy metals, and other volatile and semi-volatile organics. These are extremely toxic materials that cause cancers and leukemias, developmental disorders, genetic disorders, neurological disorders, immune system disorders, and much more.

Public health studies have identified elevated rates of certain cancers among the workers onsite associated with their exposures and in the offsite population associated with proximity to the site. An extensive, multi-year study by the UCLA School of Public Health found elevated death rates for lung cancers, lymphoma, and leukemia among workers based on their exposures to radioactivity and chemicals at SSFL. In a 2007 federal study, Professor Hal Morgenstern found rates for key cancers in members of the nearby public increased the closer the person lived to SSFL. In another federal study, Professor Yoram Cohen of UCLA found evidence of toxic exposures to the offsite population in excess of EPA standards. Studies by regional cancer registries found elevated rates of bladder cancer associated with proximity to SSFL.

SSFL contamination continues to migrate off site to communities below it. As long as the site doesn't get cleaned up, that will continue. From a public health perspective the Dept. of Energy must comply with the AOC to clean up all detectable contamination. The Trump Administration's recent actions to breach the legally binding cleanup agreement the federal government executed with California is deeply troubling and must be fought. Dear Mayor Garcetti, Council President Wesson, Honorable Councilmembers, Controller Galperin, and City Attorney Feuer,

Since last fall when I first saw this issue - the cleanup of the Santa Susana Field Laboratory - as proposed litigation, I began reaching out to my Councilmember's office. I am trying to understand what outside experts the City has hired to read and to advise them related to the letter attached signed by the City Engineer.

I believe it was last July when I first found that letter on the Committee to Bridge the Gap website. I sent it to Mr. Moore, and I asked who at the City had read the DTSC Draft Programmatic Environmental Impact Report (Draft PEIR). I never received any communication from him, but I was contacted by staff in his office. I never got an answer as to who read the report. http://committeetobridgethegap.org/wpcontent/uploads/2018/01/Final-Joint-Comment-Letter-on-Draft-PEIR-171207.pdf

So it appears in this CPRA response from that department - attached, that Councilmember Englander had signed a document appropriating \$100,000 for funding an independent expert to read the Draft PEIR. But as the result of this CPRA, I still have not found out if Engineering ever hired that outside expert. As a result, it appears that Mr. Moore signed onto the letter in the attachment below with the City Seal on letterhead with two non- profits. Why would the City submit comments to DTSC without their own letterhead signed by the Mayor or the City Attorney? Does Mr. Moore believe that he was signing onto a letter authored by a college professor in this area of expertise?

Please find out if the City of Los Angeles expended \$100,000 for a consultant, and who that consultant was, and make that information available to the public before you take any further action.

And please, do as Councilmember Englander requested - seek outside independent experts (no experts affiliated with the parties in the current and past lawsuits) to review the DTSC Draft PEIR, the DOE's Final Environmental Impact Statement, and for the future, the DTSC Final Environmental Impact Statement before you consider any litigation related to the SSFL site.

Those parties in current and historic litigation include the NRDC, Committee to Bridge the Gap (CBG), Physicians for Social Responsibility - Los Angeles (PSR-LA), Consumer Watchdog, and the Southern

California Federation of Scientists.

I have attached the summary of this legal case by PSR - LA, CBG et al below. In that record is their notice of appeal which now further delays the cleanup of the SSFL site.

> Re: Comments on the Draft Program Environmental Impact Report and Draft Program Management Plan for the Santa Susana Field Laboratory

Dear Secretary Rodriguez and Director Lee:

Thank you for the opportunity to comment on the September 2017 Draft Program Environmental Impact Report (PEIR) for remediation of contamination at the Santa Susana Field Laboratory (SSFL). We object to the approval of the project as currently proposed based on various deficiencies in the PEIR described here and in other submitted comments.

Background - A Highly Contaminated Site With Half a Million People Living Nearby

SSFL is one of the most contaminated sites in the state. Over the years, the site maintained ten nuclear reactors, a plutonium fuel fabrication facility, a "hot lab" for disassembling highly irradiated nuclear fuel, and open-air "burn pits" where radioactively and chemically contaminated items were burned. The poor environmental and safety practices of the Responsible Parties [the Department of Energy (DOE), NASA, and Boeing] and their predecessors resulted in numerous releases and spills on the site which subsequently

contaminated soil, groundwater, and surface water with radioactivity and toxic chemicals, as well as numerous buildings. Examples of poor practices and negligence included a partial meltdown in one reactor; three others had accidents; radioactive fires occurred in the hot lab, and decades of open burning of contaminated items. Tens of thousands of rocket tests and associated activities further contributed to widespread contamination with highly toxic substances such as polychlorinated biphenyls (PCBs), dioxins and furans, metals, perchlorate, and volatile and semi-volatile organic compounds.

SSFL was established 70 years ago and was supposed to be a remote field lab for work too dangerous to conduct near populated areas. However, over the decades the nearby population mushroomed so that there are now more than 150,000 people living within 5 miles of the site and more than half a million people living within 10 miles.

Federally funded studies found significant increases in death rates from key cancers among previous SSFL workers associated with occupational exposures(s). Additionally, studies have measured offsite migration of pollutants at concentrations in excess of U.S. Environmental Protection Agency (USEPA) levels of concerns, with a greater than 60 percent higher incidence of key cancers among people living near SSFL than those living further away. Because SSFL is located in hills overlooking the City of Los Angeles and other populated areas below, the contamination migrates downgradient, where neighboring communities can be exposed. Cleanup of the contamination source is therefore critical. However, the Responsible Parties have had a history of resisting those cleanup obligations.

NRDC, City of Los Angeles, CBG v. DOE Lawsuit Blocked DOE's Prior Attempt to Walk. Away from Cleaning Up Most of the Contamination

The Responsible Parties have had a history of resisting previous cleanup obligations. Fifteen years ago, DOE proposed cleanup standards for SSFL that would have left the great majority of the contamination not cleaned up. The City of Los Angeles, the Natural Resources Defense Council (NRDC), and the Committee to Bridge the Gap (CBG) filed a lawsuit in U.S. District Court, challenging the legality of DOE's actions under the National Environmental Policy Act (NEPA), 42 U.S.C. §4321, et seq. In 2007, in an Order highly critical of DOE,

Federal District Judge Samuel Conti, granted summary judgment for the plaintiffs and against DOE.

In 2010, DOE, NASA, and the California Department of Toxic Substances Control (DTSC) executed Administrative Orders on Consent (AOC), legally binding agreements requiring the cleanup of contaminated soil (including the buildings) to background, i.e., to the condition it was in before being polluted. In 2010, DTSC committed that Boeing would be required to clean up its portion of the property to background concentrations so as to be safe for all land use designations allowed under the Ventura County General Plan.

As per the 2007 Consent Order and 2010 AOCs, the soil cleanups were to be completed by 2017. However, 2017 is nearly over and the promised cleanup not only has not been completed, it has not yet even begun.

The 2017 Draft PEIR Breaches DTSC's Cleanup Commitments

The project description states that the primary objective of the proposed project is to implement the 2007 Consent Order and the 2010 AOCs. The Draft PEIR for the SSFL site cleanup, however, is at odds in numerous respects with this stated primary project objective and DTSC's longstanding commitments in the orders. These defects taint the entire PEIR from the proposed project description and analysis, to the selection and analysis of project alternatives, to the proposed mitigation. Examples are:

- 1. The AOCs bar consideration of "leave in place" alternatives.
- a. Yet, in the Draft PEIR, DTSC proposes to leave in place large amounts of contamination in the hope that over long periods of time concentrations would "naturally attenuate."
- b. DTSC also proposes to leave in place large amounts of contamination based on biological and cultural considerations that appear to go far beyond the tightly delimited exemptions allowed in the AOCs. Proposing to exempt contaminated areas from cleanup for supposed biological reasons would have a contrary effect allowing biological receptors to be damaged by radioactive and toxic chemical contamination at levels well above concentrations DTSC has already determined to cause adverse effects. It is the failure to clean up the contamination that would place those ecological receptors at risk, yet the Draft PEIR fails to analyze those risks and proposes cleanup levels and cleanup exemptions that would allow exposures far above the level DTSC itself has determined would put them at risk.
- 2. For the Boeing-controlled areas, DTSC had stated in 2010 that its normal procedures applicable to all cleanups required a cleanup so that all of the land uses allowed by local zoning and General Plan designations would be safe; DTSC noted that those designations for SSFL allow a wide range of suburban residential and rural residential/agricultural uses, the latter of which is the most protective standard; and that cleanup to that standard would be equivalent to the cleanup-to-background standard of the AOCs.

- a. However, in the Draft PEIR, DTSC does not propose cleanup to any of these promised standards, and indeed, removes each of them from even consideration. In the Draft PEIR, DTSC declares that the cleanup required will be less rigorous than that required by the AOCs; it removes from consideration cleanup to background; and it does not even mention or in any fashion consider cleanup to the promised rural residential/agricultural standards.
- b. Both Boeing and DTSC had long promised that the cleanup of the Boeing-controlled portion of SSFL would at least be to a suburban residential standard, so that the people living nearby would be reassured as to their safety. That standard, which includes risks from consumption of fruit and vegetables from a backyard garden, was established in the Standardized Risk Assessment Methodology (SRAM) prepared by Boeing and approved by DTSC, as the SRAM-based suburban residential garden standard.
 - i. However, in the Draft PEIR, DTSC removes from consideration its own SRAM-based suburban residential garden standard and instead asserts that it will only consider cleanup to levels that are more than 25 times less protective. Elsewhere in the Draft PEIR, even weaker standards are put forward, approximately 60 times less protective than DTSC's official SRAM-based suburban residential standard. This would leave the great majority of contamination not cleaned up.
 - ii. Furthermore, Boeing has recently announced it is reversing its longstanding promise to a suburban residential standard at all and wants to instead use a recreational standard, even weaker than the extremely lax cleanup levels being considered in the Draft PEIR, that would relieve them of cleaning up virtually any of the contamination.
- 3. The AOCs require cleanup of all structures, anthropogenic materials, and debris to background and that all wastes with radioactivity above background be disposed of in offsite licensed/authorized Low Level Radioactive Waste disposal facilities. However, in the Draft PEIR, DTSC ignores these requirements and says buildings in the SSFL areas controlled by the AOCs can be demolished and disposed of without DTSC approval and the debris sent to recyclers and disposal sites not licensed or authorized for Low Level Radioactive Waste.

The Draft PEIR is deficient in other ways, including:

- 4. A draft Environmental Impact Report has at its core the requirement for full disclosure of what project is being proposed, the alternatives, and the proposed mitigation. These requirements under CEQA facilitate the statute's informational role and are to allow the public, not involved in the preparation of the draft document, to understand and consider meaningfully the environmental issues raised by the proposed project. These requirements have not been met by the PEIR. DTSC is years late in issuing the Draft PEIR. It has had plenty of time to include the true program proposal. There is no good reason why what is actually being contemplated and the alternatives to be considered are not specified and properly evaluated in the Draft PEIR. For example,
- a. DTSC states in the Draft PEIR that it intends to allow an unspecified amount of soil at unspecified locations that is contaminated with unspecified concentrations of unspecified contaminants to "naturally attenuate" over unspecified times based on unspecified mechanisms of attenuation according to unspecified sources.

- b. DTSC additionally says in the Draft PEIR that it intends to allow an unspecified amount of soil at unspecified locations that is contaminated with unspecified concentrations of unspecified contaminants to be exempted for unspecified purported biological or cultural reasons with no attempt to even try to demonstrate how that would comply with the very narrow exemptions allowed in the AOCs.
- c. Furthermore, DTSC states that the actual amount of contamination it will consider allowing Boeing to avoid cleaning up will not be disclosed until after finalization of the Draft PEIR, nor will the alternative amounts it will choose from be disclosed in the Draft PEIR. Additionally, the Draft PEIR does not disclose how much contamination is in the Boeing areas, so there is no way to precisely assess how much contamination is being contemplated to not be cleaned up.
- d. Particularly troubling is that DTSC has failed to make publicly available the documents referenced in the Draft PEIR as forming the basis for assertions and conclusions therein, making it impossible to meaningfully comment on the Draft PEIR and to ascertain the validity of many of the Draft PEIR claims.
- 5. An EIR also has as its core the requirement for a thorough examination of the environmental impacts of the alternatives being considered, including the No Action Alternative. However, this Draft PEIR contains hundreds of pages identifying the purported negative impacts of cleaning up contamination at SSFL, but essentially no analysis of the environmental impacts of not cleaning up part or all of it. There is basically no review of the environmental impacts of the radioactive and toxic chemical contamination and the impacts that would ensue were DTSC to break its commitment to a full cleanup. As such, the Draft PEIR becomes not a genuine environmental review but instead a kind of advocacy, attacking the very commitments DTSC had made without a word about the impacts were it to break those promises to remediate the pollution. This results in the extraordinary claim in the Draft PEIR that the environmentally superior alternative is the No Action Alternative, because it supposedly involves no environmental impacts. That assertion is baseless, and can only be made because DTSC failed altogether to analyze any impact from the contamination that is what led to the need for cleanup in the first place.
- 6. DTSC argues for not requiring the full cleanup it had promised in the AOCs in part based on generalized assertions about protecting biological features, despite the fact that the AOCs already have carefully tailored provisions for such protection, which DTSC now appears to intend to go far beyond. However, DTSC fails in the Draft PEIR to consider impacts on plants and animals from the contamination that DTSC now is contemplating not cleaning up. DTSC has Ecological Risk-Based Screening Levels (EcoRBSLs) for the contaminants at SSFL, levels set to determine what levels one needs to bring concentrations down to in order to protect ecological receptors such as birds, mammals, and various plants. The Draft PEIR needs to use the invertebrate, plant, and Ecological Low TRV-Based RBSLs.
- 7. The Draft PEIR simply repeats, without critical review, soil volume estimates by DOE and NASA that grossly inflate the actual volume of contaminated soil. At the same time, the Draft PEIR accepts soil volume estimates by Boeing that grossly underestimate the amount of contaminated soil it should clean up.

- 8. Much of the Draft PEIR appears to be an attempt to inflate the impacts of cleaning up while trivializing the risks of abandoning in perpetuity significant amounts of radioactive and chemical contamination.
- 9. The Draft PEIR fails to identify and meaningfully evaluate reasonable alternative methods of contaminated soil conveyance and routes, including direct site to rail conveyance and other options including the use of fire roads and routes with less impact to residents and reduced traffic impact. Instead, straw men are put forward and rejected. The Draft PEIR is also silent about the harm from the toxic and radioactive pollution but spends many pages about the inconvenience from the trucks needed to transport the contaminated soil for disposal. Transportation alternatives, including alternative routes and means of conveyance that could reduce truck impacts, are not seriously examined.

Draft Program Management Plan

The Draft Program Management Plan is deficient in that it provides very little detail as to what is actually proposed regarding cleanup and defers to a post-PEIR, post-CEQA phase most identification of actual cleanup proposals.

Conclusion

The Draft PEIR is deficient in that it violates longstanding DTSC commitments for a full cleanup, is not clear in its disclosure of the proposed remediation, and does not address the negative ecological and human health impacts from exposure to the contamination itself and which would occur were the promised full cleanup not to occur. What DTSC appears to be contemplating is to leave in place the great majority of the contamination.

The public that resides in the area surrounding the site will be at continued and perpetual risk if DTSC continues on this course. CEQA also requires that the long term protection of the environment must be the guiding criterion in public decisions. Because the Draft PEIR is so fundamentally and basically inadequate and conclusory in nature, meaningful public review and comment have been precluded. We therefore request extensive revision and recirculation of the Draft PEIR, and careful selection of a responsible remediation approach that is fully in compliance with the DTSC's previous commitments for a complete cleanup of the SSFL contamination.
