

Subject: **TRANSFER OF ARTS AND CULTURAL ASSETS FROM COMMUNITY REDEVELOPMENT AGENCY/LOS ANGELES (CRA/LA) TO THE CITY OF LOS ANGELES CULTURAL AFFAIRS DEPARTMENT**

### RECOMMENDATIONS

That the Council, subject to the approval of the Mayor:

1. Authorize the Department of Cultural Affairs to enter into an agreement with the Community Redevelopment Agency/Los Angeles (CRA/LA), a Designated Local Authority, to accept the transfer of \$5,259,288 and to assume responsibility to administer active art covenants for public artworks, programs, and projects on private property, subject to the approval of the City Attorney as to form;
2. Request the City Attorney to create a special trust fund, in accordance with the proposed agreement with Community Redevelopment Agency/Los Angeles (CRA/LA), for the deposit of \$5,259,288 in Cultural and Arts funds to be managed by the Department of Cultural Affairs pursuant to the Public Art Policy adopted by the former Community Redevelopment Agency of the City of Los Angeles and approved by the Council (C.F. 00-1847-S1);
3. Authorize by resolution two Arts Manager I positions, Class Code 2455-1, within the Department of Cultural Affairs for a term of March 1, 2019 to June 30, 2019, to provide administrative services for the support of the trust funds and art covenant agreements, subject to position allocation by the Board of Civil Service Commissioners and pay grade determination by the Office of the City Administrative Officer (CAO), Employee Relations Division;
4. Authorize the General Manager of the Department of Cultural Affairs Department, or designee, to prepare Controller instructions and/or make technical adjustments consistent with Council and Mayor action, subject to approval of the CAO, and authorize the Controller to implement those instructions.

## **SUMMARY**

In 1993, the Community Redevelopment Agency of the City of Los Angeles (Former Agency) adopted a public art policy (Policy) which mandated that developers receiving assistance from the Former Agency incorporate a One Percent for Public Art fee in their development projects. The Policy was approved by the Los Angeles City Council (C.F. 00-1847-S1). Upon the dissolution of the Former Agency in 2012, the Community Redevelopment Agency/Los Angeles (CRA/LA), was formed as the Designated Local Authority to serve as the successor agency.

On January 4 and 11, 2018, the Governing and Oversight Boards of CRA/LA approved Recognized Obligation Schedule (ROPS) 18-19 which provided for the transfer of Cultural Arts Trust Funds to the City of Los Angeles (City). The Department of Finance (DOF) for CRA/LA approved the transfer on April 10, 2019. As a condition of the transfer, the City will agree to accept the assignment of the remaining Art Covenants. On August 2, 2018, CRA/LA proposed the Transfer of Art Funds and Assignment of Art Covenants Agreement (Agreement) for the transfer of retained Cultural Trust Funds to the City. The Art Covenants proposed for assignment require that private developers maintain the covenanted art installations for a specified period of time for the benefit and enjoyment of the public. The project areas are included in the Agreement as Schedule A. The List of Art Covenants is included as Schedule B. The Agreement requires that the funds be transferred into a specially created trust fund managed through the Department of Cultural Affairs (Department).

Per the Department, the CRA/LA Art Policy allows that up to 15 percent of the fund's total revenues (\$788,893) may be utilized for administrative charges to manage the projects. This level of funding would pay the salaries and related costs for two Art Manager I positions for approximately three years. Funding for subsequent years would be provided by the Arts and Cultural Facilities and Services Trust Fund and would be appropriated each year through the City's budget process.

## **FISCAL IMPACT STATEMENT**

There is no General Fund impact as a result of the recommendations of this report. Funding for the salaries and related costs of the proposed positions for the first three years is provided by the transfer of Cultural Arts Trust Funds to the City of Los Angeles. Additional funding, if needed, will be provided by the Arts and Cultural Facilities and Services Trust Fund. The recommendations included in this report are consistent with the City's Financial Policies as on-going expenditures are supported by on-going revenues.

### **RE: TRANSFER OF ARTS AND CULTURAL ASSETS FROM CRA/LA TO THE CITY OF LOS ANGELES DEPARTMENT OF CULTURAL AFFAIRS AND REQUEST FOR RESOLUTION AUTHORITY FOR TWO ARTS MANAGER POSITIONS**

#### **SUMMARY**

The Department of Cultural Affairs (DCA) requests authority to enter into an agreement with CRA/LA, a Designated Local Authority (CRA/LA), to accept the transfer of Cultural and Art Trust Funds up to \$5,259,288 as well as to administer active art covenant agreements for public artworks on private property that DCA will manage for the duration of the agreements. The CRA/LA Governing Board approved this transfer of art funds and assignment of art covenants agreements at its meeting of August 2, 2018 and DCA requests approval to finalize and execute the approved agreement.

To accept these funds, the City Attorney is requested to prepare and present an ordinance amending the Cultural Affairs Department Trust Fund (Ad. Code Sec. 5.111.2) to deposit these funds into a specific account to be managed by DCA, pursuant to the Public Art Policy adopted and amended by the Former Agency and approved by the City Council (C.F. 00-1847-S1). Additionally, DCA requests two Arts Manager resolution authority positions to provide sufficient administrative services to manage the art covenant agreements and Trust Fund program and project management and implementation.

#### **RECOMMENDATION**

That the Council, subject to the approval of the Mayor:

1. **AUTHORIZE** the Department of Cultural Affairs to enter into an agreement with CRA/LA to accept the transfer of \$5,259,288 and to assume responsibility to administer active art covenants for public artworks, programs, and projects on private property.
2. **INSTRUCT** the City Attorney to amend the Cultural Affairs Department Trust Fund (Ad. Code Sec. 5.111.2), in accordance with the City's Administrative Code, for the deposit of \$5,259,288 in Cultural and Art funds to be managed by DCA pursuant to the Public Art Policy adopted by the Former Agency and as approved by the City Council in 2005 (C.F. 00-1847-S1).

3. APPROVE by resolution, subject to position allocation by the Board of Civil Service Commissioners and by the City Administrative Officer, one Arts Manager III position (Class Code: 2455-3) and one Arts Manager II (Class Code: 2455-2) position for the period January 1, 2019 to January 1, 2022 to provide administrative services of the former CRA/LA Trust Funds and art covenant agreements.
4. AUTHORIZE the General Manager of DCA, or designee, to prepare Controller instructions and/or make technical adjustments that may be required to appropriate and expend from the new special Trust Fund, subject to the approval of the CAO, and authorize the Controller to implement requested instructions.

## **BACKGROUND**

Upon the dissolution of the Community Redevelopment Agency (Former Agency) in 2012, and in accordance with California Health and Safety Code Section 34173(d)(3), CRA/LA – a Designated Local Authority (CRA/LA) was formed to serve as the successor agency.

Pursuant to the Dissolution Statutes, all assets, properties, contracts, leases, books and records, buildings, and equipment of the Former Agency were transferred to the control of CRA/LA for administration and dissolution of all property and assets.

In 1993 the Former Agency adopted a public art policy (Policy) that mandated developers receiving agency assistance to incorporate a 1% for Public Art fee in their development projects, often resulting in an “Art Covenant” being placed on the development. As of February 1, 2012, the Former Agency was dissolved pursuant to California Health and Safety Code Section 34172.

On August 2, 2018, the CRA/LA Governing Board approved the authorization to execute transfer of art funds and assignment of art covenants agreements to the City of Los Angeles under DCA’s stewardship.

### **CRA/LA Art Policy**

The CRA/LA’s Art Policy was previously adopted, amended, and approved by the City Council (C.F. 00-1847-S1). The Cultural and Art Trust Funds (the Funds) and Developer-Led Public Art Covenants on private property, once transferred to the control of DCA, shall be expended and managed in compliance with the revised Art Policy established by the Former Agency, as approved by the City Council on March 2, 2005. The City has on multiple occasions, 1993 and 2005, endorsed and adopted the CRA Art Policy. The intention of the Art Policy is to make artists and the arts primary resources in the revitalization of the City. Through the application of this Policy, the CRA/LA, the City, and its communities were able to reap physical, social, cultural, and economic benefits that have strengthened and sustained communities over time.

As such, the City, under the stewardship of DCA, desires to take over the CRA/LA Art Policy in its entirety of operation and implementation, and use this policy as the guiding documents in managing the Former Agency’s Funds and Art Covenants.

### **Transfer of Funds and Covenants**

The Funds and Art Covenants to be transferred are all tied to specific redevelopment areas in the City. The Funds and Covenants cover the following project areas:

- Beacon Street
- City Center
- Hollywood
- Hoover
- Little Tokyo
- Mid City
- Monterrey Hills
- North Hollywood
- Pacoima/Panorama
- Wilshire/Koreatown

Through the transfer agreement, DCA will assume responsibilities over projects on private property with active art covenants, based on the adoption of the CRA/LA's Art Policy, and ensure that the Funds retained are spent in these project areas and that the publicly-assisted art investments are maintained.

### **Arts Manager III and II Resolution Authorities Request**

The two new Arts Managers, III and II, resolution authority positions will implement and administer this program transferred to DCA to manage the former CRA/LA's Trust Funds and Art Covenants. The Arts Manager III position will be responsible for all aspects of this program, including management of funds and direct oversight of project development, which includes interacting with other public agencies and private firms relating to the selection and installation of public art projects, reporting and making recommendations to executive management, and supervising the development of the necessary database, tracking and enforcement mechanism and processes to administer the Art Covenants. The Arts Manager II, under the direction of the Arts Manager III, will develop the Administrative Guidelines, process and reporting system to develop the annual expenditure plan.

In addition, these positions will assist in managing the art program and project development and implementation, contracting, and routine administration processes based on the Adopted Art Policy. The two senior positions are needed to effectively manage this very sophisticated and complex transfer of assets and fold them into the DCA's portfolio of managing special funds and implementing public art programs/projects. We estimate the extent of the workload to be significant and require specialized, high level expertise that warrant two senior positions to undertake this work. Lower classifications would require additional training and time to gain the necessary skills to readily perform the job required for this Developer-Led Public Art programs/projects. These positions will be requested annually through the budget process.

### **FISCAL IMPACT STATEMENT**

There is no General Fund impact. All direct and indirect costs for these positions will be provided by funds received through the transfer of CRA/LA Cultural and Art Trust Funds, in accordance with the CRA/LA's Art Policy which allows up to 15% of the Funds total revenues (approximately \$788,000) to be utilized for administrative charges to manage the projects for at least three years.

**SUBJECT:** **CULTURAL AND ART TRUST FUNDS.** Authorization to execute Transfer of Art Funds and Assignment of Art Covenants Agreement with the City of Los Angeles.

**RECOMMENDATION**

That the Governing Board authorize the Chief Executive Officer to execute an agreement with the City of Los Angeles for administration of active art covenants, in consideration for the transfer of retained Cultural Trust Funds.

**SUMMARY**

The recommended action would facilitate the transfer of \$5,259,288 in retained Cultural and Arts Trust Funds, in consideration of the City's agreement to assume responsibility to administer active art covenants. The art covenants proposed for assignment to the City require private developers to maintain the covenanted art installations for a specified period of time for the benefit and enjoyment of the public.

**BACKGROUND AND DISCUSSION**

Pursuant to the Art Policy, the Former Agency determined a private project's art budget at 1 percent of total development costs. Developers were required to deposit 40 percent of the art budget into the respective project area's cultural trust fund. The trust fund monies were used to pay for public art installations in the project area, cultural programming and other eligible uses. The City of Los Angeles operates a very similar public art program through its Cultural Affairs Department (CAD). The Successor Agency believes that the CAD is the best public institution to manage these funds, consistent with the Art Policy's original intent. It is appropriate, therefore, to transfer cultural trust funds to the stewardship of the CAD.

As a condition of the transfer of cultural trust funds, the City has agreed to accept the assignment of the remaining art covenants. There are 19 projects with active art covenants. Assigning the covenants to the City will further the successor agency's winding down process, reduce liabilities and ensure the publicly-assisted art investments are maintained.

**PREVIOUS ACTIONS**

January 4 and 11, 2018 – Governing and Oversight Boards, respectively, approved ROPS 18-19, which included line item 1361 providing for the transfer to the City of Cultural and Art Trust Funds retained by the Successor Agency. DOF approved ROPS 18-19 on April 10, 2018.

**SOURCE OF FUNDS**

The funds to be transferred to the City, identified as Reserve Balance, constitute developer contributions to the Former Agency in compliance with the Art Policy. The funds were retained by CRA/LA through the Other Funds & Accounts Due Diligence Review.

**ROPS AND ADMINISTRATIVE BUDGET IMPACT**

The transfer of the funds is consistent with the approved ROPS 18-19.

**ENVIRONMENTAL REVIEW**

The recommended action does not constitute a "project" as identified by the California Environmental Quality Act.

## TRANSFER OF ART FUNDS AND ASSIGNMENT OF ART COVENANTS AGREEMENT

This Transfer of Art Funds, and Assignment of Art Covenants Agreement (this "Agreement") is made as of \_\_\_\_\_, 2018, by and between CRA/LA, a Designated Local Authority, a public body formed under California Health and Safety Code Section 34173(d)(3) ("CRA/LA") and successor to The Community Redevelopment Agency of the City of Los Angeles (the "Former Agency"), and the City of Los Angeles, a municipal corporation, (the "City"), acting by and through the Department of Cultural Affairs (the "Department") with reference to the following recitals of fact:

### RECITALS

A. In 1993, the Former Agency adopted the Public Art Policy that required a fee to be paid by developers for the development of art and cultural amenities. The Former Agency encouraged developers receiving agency assistance to incorporate art in the development projects. The Former Agency modified the Public Art Policy in 2005 to more closely conform to the City's Art Development Fee Ordinance and Procedures. Pursuant to the Public Art Policy, a developer was required to deposit all or a portion of the required art fee into a Cultural Arts Trust Fund for the redevelopment project area (the "Project Area") in which the development was located.

B. For developers who incorporated art in their development projects, the Public Art Policy required the developer to execute a covenant agreement obligating the developer to maintain the artwork for the term of the covenant.

C. As of February 1, 2012, the Former Agency was dissolved pursuant to California Health and Safety Code Section 34172.

D. Pursuant to California Health and Safety Code Section 34173(d)(3), CRA/LA was formed to serve as the successor agency to the Former Agency. California Health and Safety Code Section 34175(b) required that all assets, properties, contracts, leases, books and records, buildings, and equipment of the Former Agency to be transferred to the control of CRA/LA for administration.

E. CRA/LA currently maintains a total of Five Million Two Hundred Fifty Nine Thousand Two Hundred Eighty Eight Dollars (\$5,259,288) in the various CRA/LA project area Cultural Art Trust Funds. The amounts in each project area Cultural Art Trust Fund are listed on Schedule A (the "Trust Funds"), attached hereto and fully incorporated herein.

F. CRA/LA has identified that it is the beneficiary under 19 Arts Covenants, which covenants are listed in Schedule B (the "Art Covenants"), attached hereto and fully incorporated herein.

G. CRA/LA desires to transfer the Trust Funds to the City, which will be placed in a specially created trust fund managed by the Department of Cultural Affairs. The Trust Funds will be expended by the City pursuant to the Public Art Policy adopted by the Former Agency

and as approved by City Council in 2005, and as amended as necessary. A payment to the City of up to Five Million Two Hundred Fifty Nine Thousand Two Hundred Eighty Eight Dollars (\$5,259,288) has been listed as Line 1824 on approved ROPS 18-19.

H. CRA/LA desires to assign its rights, interests, duties and obligations under the Art Covenants to the City, and the City desires to accept and assume such rights, interests, duties and obligations as more fully set forth herein.

NOW, THEREFORE, for good and valuable consideration, including the mutual covenants contained in this Agreement, CRA/LA and the City agree as follows:

#### **AGREEMENT**

1. Effective Date of Agreement. This Agreement shall take effect upon the last date of execution by the both the City and CRA/LA (the "Effective Date").

2. Transfer of Trust Funds. CRA/LA shall transfer the Trust Funds to the City in the amount of Five Million Two Hundred Fifty Nine Thousand Two Hundred Eighty Eight Dollars (\$5,259,288) within thirty (30) days following the Effective Date. The City shall place the Trust Funds into a specially created trust fund managed through the Department of Cultural Affairs in compliance with a City adopted ordinance and the Public Art Policy adopted by the Former Agency and approved by City Council, and as amended as necessary.

3. Assignment and Assumption. As of the Effective Date, CRA/LA hereby assigns and transfers to City all of its rights, interests, duties and obligations under the Art Covenants and, as of the Effective Date, City accepts the assignment and transfer and assumes and agrees to perform all such obligations of the CRA/LA under the Art Covenants.

4. City/CRA/LA Hold Harmless. City shall indemnify, defend and hold CRA/LA harmless from and against all damages, liabilities, losses, claims, expenses and reasonable attorneys' fees arising out of, involving, or in connection with all obligations of CRA/LA under the Art Covenants and collection of the Art Funds arising after the Effective Date of this Agreement. CRA/LA shall indemnify, defend and hold City harmless from and, against all damages, liabilities, losses, claims, expenses and reasonable attorneys' fees arising out of, involving, or in connection with all obligations of CRA/LA under the Art Covenants and collection of the Art Funds arising prior to the Effective Date of this Agreement.

5. Governing Law. This Assignment shall be governed by, and construed in accordance with, the laws of the State of California.

6. Covenant of Further Assurances. The parties agree to execute such other documents and perform such other acts as may be necessary or desirable to carry out the purposes of this Agreement.

7. Successors and Assigns. This Assignment shall inure to the benefit of, and be binding upon, the parties hereto and their respective successors and permitted assigns.

8. No Attorneys' Fees. Should any action be brought arising out of this Assignment, including, without limitation, any action for declaratory or injunctive relief, each party shall bear their own attorneys' fees and costs and expenses of investigation as may be incurred.

9. Entire Agreement. This Assignment, including and incorporating the Recitals, represents the entire agreement between the parties with respect to the subject matter of this Assignment and supersedes all prior oral or written agreements, understandings, representations, and covenants.

10. Terminology. All personal pronouns used in this Assignment, whether used in the masculine, feminine or neuter gender, shall include all other genders; the singular shall include the plural; and the plural shall include the singular. Titles of sections in this Assignment are for convenience only, and neither limit nor amplify the provisions of this Assignment.

11. Counterparts. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which, when taken together, shall constitute one and the same instrument.

12. Time is of the Essence. Time is of the essence in respect to every provision of this Assignment in which time is a factor.
