BACKGROUND

As a result of the passing of the Los Angeles County Safe Neighborhood Parks, Gang Prevention, Tree Planting, Senior and Youth Recreation, Beaches and Wildlife Protection Act of 1992 (Proposition A-I) and the Los Angeles County Park, Beach and Recreation Act of 1996 (Proposition A-II), the City of Los Angeles was awarded competitive, discretionary, and specified grant funds to be administered by the Department of Recreation and Parks (RAP) for various park projects.

On occasion, previously approved capital improvement projects are completed under budget resulting in residual funds, which the County of Los Angeles describes as uncommitted funds. These uncommitted funds then become available for reallocation to other projects, subject to the approval of the County of Los Angeles Board of Supervisors and the City Council, upon recommendation from the L.A. for Kids Steering Committee, which has administrative oversight of Proposition A funds, in accordance with Sections 8.325, 8.325.1 and 8.325.2 of the Los Angeles Administrative Code.

Five Proposition A-II projects have been completed and closed with the Los Angeles County (County), leaving a total residual of \$553,015.60 (see Attachment No. 1). RAP Staff has identified five projects that will benefit from the reallocation of uncommitted Proposition A-II funds, as follows:

new pool facilities in the amount of \$50,000.00.

- Alpine Recreation Center Expansion (aka Ord and Yale Park) Project Development of a new park as an extension of the existing Alpine Recreation Center in the amount of \$966.59.
- Rancho Cienega Sports Complex Phase I Project Construction of a new gymnasium and pool in the amount of \$44,786.61.
- Sepulveda Recreation Center Aquatics Pool Equipment Improvements Project Replacement/Upgrades of pool equipment and amenities in the amount of \$200,000.00.
- Sun Valley Recreation Center Sports Lighting and Area Lighting Improvement Project Install/upgrades lighting and amenities in the amount of \$257,262.40.

The above projects are receiving Prop A funding. Three of the Prop A projects, Algin Sutton Recreation Pool Replacement Project, Alpine Recreation Center Expansion Project, and Rancho Cienega Sports Complex Phase I Project are existing projects and can use additional funds. The Sepulveda Recreation Center Aquatics Pool Equipment Improvements Project and Sun Valley Recreation Center Sports Lighting and Area Lighting Improvement Project are two new projects.

On January 28, 2019, the Board of Recreation and Park Commissioners (RAP Board) approved the submission of applications for reallocation of Proposition A-II funds for the four projects that did not already have a Proposition A grant, subject to approval by Council (Board Report No. 19-005). The RAP Board also approved amending the existing Proposition A grant agreement for the Alpine Recreation Center Expansion (aka Ord and Yale Park) Project, which had previously received Proposition A funding. Additionally, the RAP Board requested that Council approve the resolutions and Youth Employment Plans that are required in order to submit the applications for the four projects that had not already received Proposition A funding.

The County is preparing to roll out Measure A in March 2019 and is focused on closing out all of the Proposition A-II projects. To date, with the four new projects discussed above and the Alpine Recreation Center Expansion Project, RAP has a total of eight active Proposition A-II projects. The active projects are estimated to be completed by the funding deadline of June 30, 2020, for Proposition A-II allocated projects.

These uncommitted funds then become available for reallocation to future projects, subject to the approval of the County of Los Angeles Board of Supervisors and the City Council directly or through its designated L. A. for Kids Steering Committee (LAFKSC), which has administrative oversight of Proposition A funds, in accordance with Sections 8.325, 8.325.1 and 8.325.2 of the Los Angeles Administrative Code.

Five (5) Prop A projects have been completed and closed with the Los Angeles County (County), leaving a total residual of Five Hundred Fifty-Three Thousand, Fifteen Dollars and Sixty Cents (\$553,015.60) (Attachment No. 1). RAP Staff has identified five (5) projects that will benefit from the reallocation of uncommitted Proposition A funds, as follows:

- Algin Sutton Recreation Pool Replacement Project Replace existing pool with new pool facilities in the amount of Fifty Thousand Dollars (\$50,000.00) (Proposition A-II funds).
- Alpine Recreation Center Expansion (aka Ord and Yale Park) Project Development
 of a new park in the amount of Nine Hundred Sixty-Six Dollars and Fifty-Nine Cents
 (\$966.59) (Proposition A-II funds).
- Rancho Cienega Sports Complex Phase I Project Construction of a new gymnasium and pool in the amount of Forty-Four Thousand, Seven Hundred Eighty-Six Dollars and Sixty-One Cents (\$44,786.61) (Proposition A-II funds).

- Install/upgrades lighting and amenities in the amount of Two Hundred Fifty-Seven Thousand Two Hundred Sixty-Two Dollars and Forty Cents (\$257,262.40) (Proposition A-II funds).

With regards to the Youth Employment Plan (YEP), the Proposition A grant program places a special emphasis on employing youth in park development projects and hence, requires the governing body of the Grantee to adopt a YEP for each Prop A funded park development project. In keeping with this emphasis on youth employment, the Los Angeles County Regional Park and Open Space District determined that the City of Los Angeles's Proposition A Youth Employment Goal (YEG) is Twelve Million, One Hundred Eighty-Eight Thousand, Four Hundred Eighty-Six Dollars (\$12,188,486.00) in labor wages paid (which is equal to fifty percent of Twenty-Four Million, Three Hundred Seventy-Six Thousand, Nine Hundred Seventy-Two Dollars (\$24,376,972.00) in Maintenance and Servicing funds allocated by the County to the City for Fiscal Years 1997-1998 through 2018-2019). The City has not only met its YEG but also has exceeded the goal by employing at-risk youth for a total of Fifteen Million, Six Hundred Twenty-Eight Thousand, Eight Hundred Thirty-Eight Dollars (\$15,628,838.00) in labor wages paid.

The YEPs for the Algin Sutton Recreation Center Pool Replacement Project, Rancho Cienega Sports Complex Phase I Project, Sepulveda Recreation Center Aquatics Pool Equipment Improvements Project, and Sun Valley Recreation Center Sports Lighting and Area Lighting Improvement Project, indicate that at-risk youth were considered for hire and whether at-risk youth will be employed in the development of the project. As determined by Planning, Construction and Maintenance Branch staff, due to the nature of the project, there are no tasks that can be performed by at-risk youth, and therefore, no at-risk youth will be hired for these projects.

Since the Prop A Resolution and YEP have been approved and completed for the Alpine Recreation Center Expansion (aka Ord and Yale Park) Project and there is an existing Prop A Grant Agreement for the Alpine Recreation Center Expansion Project, the County only requires an amendment to increase the grant agreement amount from Nine Hundred Fifty Thousand Dollars (\$950,000.00) to Nine Hundred Fifty Thousand, Nine Hundred Sixty-Six Dollars and Fifty-Nine Cents (\$950,966.59).

Approval of these recommendations will commit these residual Prop A funds making the City of Los Angeles eligible to apply for additional Prop A funding for projects involving trails, senior citizen facilities, urban tree planting, graffiti prevention, rivers and streams, and acquisition and/or restoration of natural lands, as well as, the acquisition, construction, development and/or improvement of at-risk youth recreation and service facilities throughout the City for gang prevention purposes.

ENVIRONMENTAL IMPACT STATEMENT:

Algin Sutton Recreation Center Pool Replacement Project, Alpine Recreation Center Expansion Project, and Rancho Cienega Sports Complex Phase I are already in construction and are in compliance with the California Environmental Quality Act (CEQA) requirements.
