Re: <u>Notification of reimbursement to the City of Los Angeles for 2019-2020 expenses</u> related to Census 2020 Outreach.

Honorable Members:

The Mayor's Office of Budget and Innovation (MOBI) requests authority to accept and appropriate funds from the City Administrative Office and the General City Purpose Fund for outreach services related to the Census.

## **SUMMARY**

On May 1, 2019, the City Council with the concurrence from the Mayor authorized the CAO with the assistance of the City Attorney and the Mayor to execute an agreement with the County of Los Angeles to accept funds for the City to engage in Census 2020 outreach and education efforts (CF 19-0360). On May 3, 2019, the County of Los Angeles notified the City of Los Angeles of its intent to allocate \$2,950,115 to the City of Los Angeles to support on the ground outreach efforts for the upcoming 2020 Census. Additionally, as part of FY 19-20 budget process, the City of Los Angeles allocated \$950,000 of City general funds to Census outreach. Combined with the County of Los Angeles allocation, a total of \$3.9 million is available to conduct Census 2020 outreach in the City of Los Angeles.

On July 31, 2019, the Mayor's Office provided a communication to the City Council laying out the City's Census 2020 Strategic Outreach Plan, which included a budget for expending the \$3.9 million. The budget allocates \$1.5 million in LA County funds and \$500,000 in City GCP funds to the California Community Foundation to issue grants to community based organizations for on the ground outreach efforts in the City of Los Angeles for a total investment of \$2 million. The Mayor's Office as the lead in the City's Census 2020 efforts will be using the remaining funds to conduct the City's outreach efforts including purchasing ads to display on the City's fleet of sanitation trucks, street poles, public transit and other locations, print and disseminate posters and flyers to city departments and community partners, conduct direct outreach at community events,

recruit/train volunteers and implement the State's Questionnaire Assistance Kiosk program in city facilities that have public computers with internet access. **Attachment 1** shows the FY 19-20 budget allocation for Census 2020 outreach efforts.

Additionally, the agreement executed on October 4, 2019 with the County of Los Angeles, requires the City of Los Angeles to submit deliverables to the County of Los Angeles Chief Executive Office in order to receive payment, see **Attachment 2**.

CF 19-0360-S2 authorizes the Chief Administrative Office (CAO) to be the City's fiscal agent and the CAO and Chief Legislative Analyst Office to administer the agreement with the California Community Foundation.

## **RECOMMENDATIONS**

It is therefore requested that the Council:

 AUTHORIZE the Controller to establish a new interest-bearing fund, entitled Census Fund No XXX, Department 46, recognize a receivable in the amount of \$2,950,115 in County Census Funds, disburse the funds upon presentation of documentation or proper demand from the Mayor's Office, and create new appropriation accounts within the new Fund XXX/46 as follows:
