Honorable Members:

At the request of the Board of Airport Commissioners (BOAC), this Office has prepared and now transmits for your consideration the enclosed draft ordinance, approved as to form and legality. The draft ordinance would allow BOAC to authorize its Chief Executive Officer to use the competitive sealed proposal selection process and alternative project delivery methods and establish criteria relating to such contracts for select capital improvement projects related to the modernization and development of a Consolidated Facilities Maintenance Utilities Group Campus (FMUG).

The effect of the draft ordinance, if adopted, would be to authorize Los Angeles World Airports (LAWA) to award construction manager at risk contracts using the competitive sealed proposal selection process for the following projects, or any combination thereof: Runway 7R-25L Rehabilitation, Runway 6R-24L Safety Area (RSA) and Rehabilitation, Runway 6L-24R Safety Area (RSA) and Rehabilitation, West

Remain Over Night (RON) Aircraft Parking Improvements, Secured Area Access Posts and Vehicle Checkpoints, North Airfield Runway Exit Taxiways Program, South Airfield Reconstruction Program, Taxiway Reconfiguration Projects, Taxilane Resurfacing Projects and Airside Cargo Facility Ramp Reconstruction Project.
