Not only does treatment instead of incarceration make our communities safer, furthermore, but the cost of probation and treatment is much less than the cost of incarceration. By targeting the underlying problems that led to the crime in the first place, effective diversion programs can improve long-term community safety and reduce recidivism far more effectively than warehousing someone in a prison cell before turning them back onto the streets. Diversion programs are also many times cheaper than incarceration. In a recent study, the National Institute on Drug Abuse has found that every dollar invested in drug treatment yields \$12 worth of savings in terms of reducing future crime and health care expenses.
