ACCEPTANCE OF AREA PLAN FISCAL YEAR 2019 - 2020 GRANT FUNDS FROM THE CALIFORNIA DEPARTMENT OF AGING (AP-1920-25)

CONSIDERATION

The Los Angeles Department of Aging (LADOA) requests authorization from City Council and Mayor to accept \$15,785,382 from the California Department of Aging (CDA) for the provision of older adult and family caregiver services (including nutrition and social services) for Fiscal Year 2019-2020. In addition, the department requests authority to execute the CDA Standard Agreement AP-1920-25.

RECOMMENDATIONS

That the City Council, subject to the approval of the Mayor:

- 1. Authorize the General Manager or designee of the LADOA to accept \$15,785,382 in grant funds from the California Department of Aging;

NARRATIVE

The LADOA receives on an annual basis new year Older Americans Act (OAA) grant funds used to fund services such as congregate nutrition, home delivered meals program, social services, and family caregiver services. This transmittal requests approval to accept \$15,785,382 in Older American Act/Older Californians Act funds for the Area Plan Fiscal Year 2019-2020 beginning on July 1, 2019. The department is requesting expedited processing of this request as the CDA requires a thirty day turnaround on approval of the budget and execution of the Standard Agreement contract. Please note a subsequent transmittal document requesting authority for new year service contracts will include necessary Controller Authorizations for both departmental and contracted services recognizing that the department will know what the City proposed budget for Fiscal Year 2019-2020 will add to the department's funding. This transmittal is requested to expedite the acceptance of the grants funds and allow the department to request grant funding at the beginning of the fiscal year.

FISCAL IMPACT STATEMENT

The proposed actions involve the acceptance of grant funds. There is no additional impact to the City General Fund. Stated General Fund dollars are part of the approved City Budget for Fiscal Year 2019-2020.
