Amidst the City's changes and iterations to accommodate for new families and people who want to make Los Angeles a home, I see so clearly that we are not doing right by my unhoused neighbors who are fighting to be counted in L.A. as well. 41.18(d) exacerbates our longstanding struggle to pull people out of poverty and homelessness. In a City of 27,000 unsheltered residents and only 9,702 emergency shelter and traditional housing beds, nearly 20,000 people – each night – sleep outside on public property because they have no home or shelter to go to. To prosecute people for doing so is unjust. By reauthorizing laws that criminalize homelessness such as 41.18d, the City promotes the discredited idea that homelessness is driven by criminality. It instead should be holding hearings on the failure to move forth necessary homeless housing projects. I urge the Council to repeal 41.18(d) outright. I urge the City to instead use its resources to create solutions instead of unjust laws that entrench poverty and criminalize the unhoused. We are in the middle of a serious homelessness crisis; we need our efforts to go towards building much-needed shelters and housing.

Comments for Public Posting: I am writing to urge the entire City Council to consider how detrimental it is to gut LAMC 41.18. The City needs to enforce appropriate rules for orderly behavior. This means that we don't need more sidewalk camping by the homeless. We need less. And if you are planning to delete 50% of the code by removing sections b and c you will also encourage more loitering and allow aggressive behavior in public spaces. The Eighth Amendment's prohibition on cruel and unusual punishment bars a city from prosecuting people criminally for sleeping outside on public property when those people have no home or other shelter to go to. In a City of 27,000 unsheltered homeless and only 9,702 emergency shelter and transitional housing beds, nearly 20,000 people each night stand to have their Constitutional protections violated by laws designed to criminalize the unhoused. In 2018, at least 1,424 unhoused people were cited under LAMC 41.18d for sitting on the sidewalk in the City of Los Angeles. Reauthorizing laws that criminalize homelessness like 41.18d promote the discredited idea that homelessness is driven by criminality, and undermine efforts to site and build much needed shelters and housing. Ktown for all has been asking for a bridge home shelter for over a year, and nothing has been done yet. If the City was serious, it would be holding hearings on the failure to move necessary homeless housing projects instead of finding ways around a court ruling. Criminalizing homelessness solves nothing. It is counterproductive and makes it harder for people to escape homelessness. We therefore urge the Council to delete 41.18(d) outright and to turn our City's resources to solutions instead of unjust laws that simply entrench poverty and criminalize the unhoused.
