We should be helping find solutions to the homelessness crisis our city is facing, not punishing the most vulnerable and worse-off members of our community. The restrictions put on where people sleep or sit make up the large majority of the city—what isn't within 500 feet of a park or school or 10 feet from a driveway? It is also a deeply flawed, impractical restriction that will cause more harm than good and make the city's homeless problem worse than it already is. It will create more tent cities and skid-row like areas, as the unhoused will be forced to stay out of so many areas of the city, including away from public bathrooms and washing areas. The places where they do congregate will, by concentrating these populations together and away from public facilities, be dirtier and unhealthier than if this restriction never existed. I implore the council to reject this inhumane, cruel, poorly designed and ill-considered restriction on where people can sleep.
