You are hereby notified that the Planning and Land Use Management (PLUM) Committee of the Los Angeles City Council will hold a public hearing on **Tuesday, August 6, 2019** at approximately **2:30 PM** or soon thereafter in the John Ferraro Council Chamber, Room 340, City Hall, 200 North Spring Street, Los Angeles, CA 90012 (entrance on Main Street), to consider: Related California Environmental Quality Act (CEQA) findings and report from the Los Angeles City Planning Commission (LACPC) relative to appeals filed by Kathryn Schorr and Scott Van Opdorp from the decision of the LACPC in approving a Categorical Exemption pursuant to State CEQA Guidelines, Section 15332, Article 19 (Class 32), for the demolition of an existing four-unit residential building and the construction, use, and maintenance of a new five-story, approximately 56-foot high apartment building with 17 residential units, with the proposed building encompassing approximately 19,589 square feet of residential floor area, for the property located at 2465-2467 South Purdue Avenue.
