

Subject: **FISCAL YEAR 2019 URBAN AREAS SECURITY INITIATIVE GRANT APPLICATION**

### RECOMMENDATIONS

That the Council:

1. Authorize the Mayor's Office of Public Safety to submit the Fiscal Year 2019 Urban Areas Security Initiative (FY19 UASI) grant application to the California Governor's Office of Emergency Services on behalf of the City of Los Angeles and the Los Angeles/Long Beach Urban Area, for the estimated \$56,236,000 allocation;
2. Adopt the Governing Body Resolution provided as Attachment A to this report to designate the City entities that will apply for and manage Federal financial assistance provided by the Department of Homeland Security (DHS) and sub-granted through the State of California; and,
3. Request the Mayor's Office to report back with the necessary actions to approve and accept the FY19 UASI award once applications are evaluated and funding is allocated by the DHS, subject to Mayor and Council approval.

### SUMMARY

The Mayor's Office of Public Safety (Mayor's Office) is providing notification to the City Council of the submission of the Fiscal Year 2019 Urban Areas Security Initiative (FY19 UASI) Grant and requests authority to adopt the Governing Body Resolution, which is provided as Attachment A to this report. Detailed funding information for specific projects under the FY 19 UASI grant is unknown at this time and the Mayor's Office will release a separate report once the award notification is received. However, based on the Grant Management Memorandum (Attachment B) from the California Governor's Office of Emergency Services (Cal OES) dated May 1, 2019, the Los Angeles/Long Beach Urban Area is to receive an estimated \$56,236,000 with an anticipated grant performance period of September 2019 through May 2022.

The Department of Homeland Security (DHS) issued a solicitation for the FY19 UASI grant in April 2019. The DHS awards funds to the State Administrative Agent, which is the Cal OES for the State of California, who in turn disperses the funds to the Urban Areas. In anticipation of this solicitation, the Cal OES instructed the Los Angeles/Long Beach Urban Area to submit its grant award application in a Grant Management Memorandum dated September 28, 2018, utilizing the FY18 UASI allocations as estimates for project funding. In a subsequent Grant Management Memorandum dated May 1, 2019, Cal OES estimated the Los Angeles/Long Beach Urban Area to receive \$56,236,000 with an anticipated grant performance period of September 2019 through May 2022.

### Application Process

The UASI grant application is developed through collaboration with public safety agencies representing the Los Angeles/Long Beach Urban Area jurisdiction. The Working Group, which is made up of 18 voting representatives from jurisdictions in the Urban Area, sets homeland security objectives, proposes programs to meet those objectives, and presents funding requests to meet each objective. The draft application is then reviewed and ratified by an 11-member Approval Authority, which represents the Los Angeles/Long Beach Urban Area jurisdiction and includes four City of Los Angeles representatives. The Los Angeles/Long Beach Urban Area Governance Structure is included as Attachment C to this report. The Mayor's Office serves as the administrative and fiscal agent for all UASI awards and submits all grant applications and related documents on behalf of the LA/LB Urban Area jurisdiction.

The primary Investment Justifications (IJs) for the FY19 UASI application were developed by the Working Group with concurrence from the Approval Authority, taking into consideration the core capabilities and gaps of the Los Angeles/Long Beach Urban Area and based on feedback provided by Cal OES and the DHS. The IJs are as follows:

#### *FY 2019 UASI Investment Justifications*

- 1. Strengthen interoperable and communications capabilities**
- 2. Strengthen information sharing, collaboration capabilities, and law enforcement investigations**
- 2A. Fusion Center/Joint Regional Intelligence Center (JRIC)**
- 3. Protection of critical infrastructure and key resources (limited to commercial airports and seaports)**
- 4. Catastrophic incident planning response and recovery**

### Governing Body Resolution

As part of the application, the Cal OES requires the submission of the Governing Body Resolution (GBR), which is included as Attachment A to this report. The GBR authorizes specified Los Angeles City Officials to execute for and on behalf of the City of Los Angeles any actions necessary for the purpose of obtaining federal assistance under FY19 UASI. The Mayor's Office will return to the City Council to request authority to accept the grant once the award notification

is received from Cal OES. At that time, detailed information regarding the funding for specific projects under the FY 19 UASI award will be identified along with the allocations for each jurisdiction within the Los Angeles/Long Beach Urban Area.

The estimated FY19 UASI grant amount identified in Recommendation 1 of this report differs from the estimated FY19 UASI grant amount identified in the Mayor's transmittal dated June 3, 2019. The Mayor's transmittal estimated the FY19 UASI grant amount as \$54,888,000, utilizing FY18 UASI grant allocations as directed by the Cal OES Grant Management Memorandum dated September 28, 2018. Subsequently, the Cal OES released a Grant Management Memorandum dated May 1, 2019, which included updated estimates, projecting the Los Angeles/Long Beach Urban Area to receive \$56,236,000 in its FY19 UASI grant allocation. Recommendation 1 of this report was formulated based upon the new information provided in the Cal OES Grant Management Memorandum dated May 1, 2019.

Recommendation 3 of this report also differs from Recommendation 3 of the Mayor's transmittal dated June 3, 2019. The Mayor's Office will be the administrator of the FY19 UASI grant and as a result, the Mayor's Office, not the City Administrative Officer, will report back with the necessary actions to approve and accept the FY19 UASI award once applications are evaluated and funding is allocated by the DHS. The Mayor's Office concurs with this revision.

## **FISCAL IMPACT STATEMENT**

There is no impact to the General Fund as a result of the recommendations in this report. The City's Financial Policies are not applicable to the report recommendations since no funding commitment is being made at this time. Approval of the recommendations in this report will allow the Mayor's Office of Public Safety to submit the Fiscal Year 2019 Urban Areas Security Initiative grant application. No matching funds are required of this grant.
