PARKING VIOLATION TRUST FUND 853

Dear Honorable Members:

The Los Angeles Department of Transportation (LADOT) requested an escheatment of \$345,185.60 from their "Parking Violation Trust Fund 853" (Fund No. 853) to the City General Fund. This money was received by LADOT for security deposits and has remained unclaimed for at least three years and therefore is eligible for transfer in accordance with State of California Government Code Section 50050-50055, the notification requirements of the City of Los Angeles Administrative Code, and current state law. LADOT has since reported that claims totaling \$327.00 have been processed, which reduces the monies available for escheat to \$344,858.60.

BACKGROUND

The State of California Government Code Section 50050-50055 provides that any money remaining unclaimed in the City Treasury for three years or more may become the property of the City after publication of a notice, provided that within the specified period of time, no verified complaint seeking to recover all or a designated part of the money is filed in a court of competent jurisdiction. Further, Sections 11.33-11.35 of the Los Angeles Administrative Code allow the legislative body to transfer these monies to the City's General Fund.

Attached herewith is LADOT's request to escheat monies from Fund No. 853 dated February 7, 2019, the Office of the City Clerk's proof of publication advertisements dated March 21, 2019, and the subsequent notices and publications executed on March 28, 2019. In accordance with Council File No. 12-1436, notice of these unclaimed monies was also posted on LADOT's website.

These notices stated that on May 21, 2019, funds received from January 1, 2014 through December 31, 2015 get would become property of the City. As of the aforementioned dates, a total of \$ 327.00 was claimed thereby reducing the amount available to escheat to \$ 344,858.60.

RECOMMENDED ACTION

In accordance with the authority of the State Government Code and City of Los Angeles Administrative Code, it is recommended that City Council, subject to the approval of the Mayor, should:

- 1. **INSTRUCT** the Los Angeles Department of Transportation and the City Treasurer to process a sum of \$ 344,858.60 from the Parking Violation Trust Fund 853: and
- 2. INSTRUCT the Controller to TRANSFER all identified eligible monies to the City's General Fund.




