2020 INNOVATION & PERFORMANCE AWARDS BACKGROUND & GUIDELINES

HISTORY

On August 15, 2019, the Innovation & Performance Awards were officially established by the Innovation & Performance Commission to recognize City Employees, Commissioners, and Neighborhood Councils that have advanced the City of Los Angeles through exemplary innovation and performance that has either improving customer service, streamlined processes, saved money, and/or enhanced the quality of life in the City of Los Angeles.

WHAT DOES THE AWARD RECOGNIZE?
