In accordance with Proposition 218, the City of Los Angeles provided notice to the property owners of the parcels in the proposed Leeward Avenue and Westmoreland Avenue Lighting District, as specified in the subject Council File. Along with that notice, each property owner received an assessment ballot weighted by the amount of the parcel's proposed assessment. There were no ballots delivered to my office by the final hearing date of June 11, 2019.

I have also forwarded a copy of these results to the Department of Public Works, Bureau of Street Lighting, for their information.

1. DENY the protests and confirm the assessments.

2. ADOPT the Ordinance levying the assessments and ordering the maintenance of the lighting system.
