You are hereby notified that the Planning and Land Use Management (PLUM) Committee of the Los Angeles City Council will hold a public hearing on **Tuesday, January 14, 2020** at approximately **2:30 PM** or soon thereafter in the John Ferraro Council Chamber, Room 340, City Hall, 200 North Spring Street, Los Angeles, CA 90012 (entrance on Main Street), to consider: Categorical Exemption (ENV-2018-3289-CE) pursuant to the California Environmental Quality Act (CEQA) Guidelines, Section 15332, Class 32, and related CEQA findings; report from the Zoning Administrator; and an appeal filed by David Taban, Frontier Holdings West, LLC and Main Fund Associates, LLC (Representative: Alexander Irvine, Irvine and Associates) from the determination of the Zoning Administrator in approving a categorical exemption from CEQA for a Conditional Use to allow the sale and dispensing of a full line of alcoholic beverages for on-site consumption in conjunction with a hotel within a ground floor bar and restaurant, a rooftop patio/bar and within controlled access-cabinets in each of the guestrooms, and a Site Plan Review for a development project (hotel) which creates or results in an increase of 50 or more guest rooms, for the property located at 1140 South Broadway (1138-1142 South Broadway), subject to Conditions of Approval.
