Conditions to be Made Part of Case File ENV-2018-3289-CE-1A and ZA-2018-3288-CUB-SPR-1A

- 1) Require that the Project be developed in accordance with Revised Exhibit A attached to the Associate Zoning Administrator's February 5, 2020 Letter of Substantial Conformance.
- 2) Prohibit bike parking racks within the four foot setback area shown on Revised Exhibit A.
- 3) Prohibit parking, loading, and the storage of goods within the four foot setback area shown on Revised Exhibit A.
