

**ORDINANCE NO. 186552**  
An ordinance amending Schedule "A" of Section 4.61 of the Los Angeles Administrative Code to reflect a class title change adopted by the Civil Service Commission for the classification of Superintendent of Planning and Development-Recreation and Parks.

**THE PEOPLE OF THE CITY OF LOS ANGELES**

**DO ORDAIN AS FOLLOWS:**

Section 1. Schedule "A" of Section 4.61 of the Los Angeles Administrative Code is amended to replace, in proper order, the class title of Superintendent of Planning and Development-Recreation and Parks, as follows:

Superintendent of Planning and Construction	MOU 36	

Sec. 2. Section 1 shall be operative on October 28, 2018, July 7, 2019, January 19, 2020, January 31, 2021, January 30, 2022, and June 19, 2022.

Sec. 3. This ordinance shall be effective upon publication, pursuant to Charter Section 252(g).

Sec. 4. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
