Part of that responsive is because I owe them a contractual duty to provide habitable premises, but part of it is just good business -- they had lots of choices of where they could live, and they chose my building. I take that seriously. They're my customers and this is my business. But there are reciprocal duties that they must give me and their neighbors in order to continue living here. First, they must pay rent on time, in full, each month. Without that income, I can't pay my mortgage, maintain their units or care for the beauty and safety of the building. Second, they must be quiet, clean and not a nuisance to me or others. The other tenants deserve their peace and their privacy. I can handle all of this on my own. If someone cannot pay rent, as they have agreed to in their contract to rent, I will try to work with them. But I am not OK with any law that attempts to rewrite the rental contract that both of us voluntarily signed. That's not fair. Two parties agreed to something without duress and with ample other opportunities to make contracts elsewhere. Please don't overstep and mandate a blanket provision in the law that rewrites our contracts. The city government is not a party to my contract. To rewrite the law is to become a party to my contract, something that neither renter nor landlord anticipated at the time of signing. I can handle renegotiating contracts without you, just like I've always done. This is my business. Please stay out of it.
