<u>Request</u>: The petitioner, Watt Communities, Attn: Benny Sam, is requesting the City to establish the name of the private driveways lying off Wheeler Avenue between Hubbard Street and Bombay Street, as shown on Exhibit "A", as Autry Way, Saddle Rock Place, Flintlock Lane, and Lost Trail Drive.

The name establishment for the private driveways are required to identify the addresses of new single family dwellings associated with Tract No. 63084, currently being processed.

The naming of the private driveways does not signify that they are either public streets or approved private streets and are for identification purposes only.
