RESOLUTION PROPOSAL

SUBJET: RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF LOS ANGELES, CALIFORNIA TO DECLARE ONE CARLOS IVAN BELTRAN (DOB: 4/24/1977, MANATI, PUERTO RICO) AND JOSE ALEXANDER CORA (A.K.A. ALEX CORA, DOB: 10/18/1975, CAGUAS, PUERTO RICO) "PERSONA NON GRATA" IN THE CITY OF LOS ANGELES FOR THEIR ROLES IN DISHONORING THE GAME OF BASEBALL.

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations or policies proposed to or pending before a local, state or federal governmental body or agency must first have been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor;

WHEREAS, the sport of baseball, since its foundation and official registration as a professional league in 1845, has grown in society so as many consider it to be both a national pastime and treasure.

WHEREAS, the first professional baseball team to move to the city of Los Angeles was the Dodgers in 1958, bringing a community together and promoting city identity, pride and loyalty for 61 year to date.

WHEREAS, this proposed resolution provisions are contained in Article 9 of the Vienna Convention. These stipulate that the receiving state may at any time and without having to explain its decision notify the sending state that one of the members is no longer welcome.

WHEREAS, it is of public domain per Major League Baseball's own investigation and further punishments, based on the reprobable actions of one Carlos Ivan Beltran (Carlos Beltran) and Jose Alexander Cora (Alex Cora) in the 2017 and 2018 baseball seasons, that their actions where not only reprobable, but one that has many of law abiding Angelinos and Dodger Fans worldwide in a rightful state of indignation and sheer anger.

WHEREAS, it's to recall, that one Jose Alexander Cora (Alex Cora) was drafted out of college in 1996 by the Los Angeles Dodgers, remaining in the organization for 8 years (2 in farm system and 6 the wearing the blue).

WHEREAS, this proposed resolution is consistent with the city of Los Angeles' efforts to defend city's honor, integrity and the advocacy of fair and honorable behavior amongst each other.

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by adopting this Resolution, the City of Los Angeles hereby declares both Carlos Ivan Beltran (Carlos Beltran) and Jose Alexander Cora (Alex Cora) "persona non grata" in the city of Los Angeles, California.
